3.One iron made "Hasua" having length 21" 6' Inch (approx.) including wooden butt recovered from the possession of Sanjoy Singh.

4.One Iron made "Hammer" having length 3"5' Inch (approx.) including Iron butt having length 9"5' recovered from the possession of Amar Yadav.

5.One Iron made "rod" having length 25' Inch (approx.) recovered from the possession of Raj Dom

I, SI SibdhanKarmakar of Pradhannagar P.S, SPC would like to lodge this written complaint against the above noted accused persons and others to the effect that on 21.10.22 at 00.20 hrs I received a source information that 12/14 persons were assembled at Baghajatin River Side near Mukta Mancha under Pradhan nagar P.S. area with deadly weapons with a view to commit some heinous crime. Accordingly, I inform to you and diarized the matter vide PDN PS GDE No. 1140 and as per your kind instruction myself along with ASI Manoj Kr dtd.21.10.22 Jagadish Biswas, CV/645 Das, CV/992 Pankaj Baban Roy, CV/646 Ch Gupta, CV/223 Swapan Chettri, CV/128 Ajay Kr Sahani took departure for the spot . We reached near the spot as confirmed by the source and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. At about 00.55 hrs we reached at Baghajatin River Side near Mukta Mancha under Pradhan nagar P.S and found a group of 12/14 persons assembled and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately, one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing in multiple directions. Somehow, after a hot chase we could able to apprehend the above noted 05(Five) persons.

On interrogation they disclosed their identity noted above and also stated that they along with other associates with them had assembled there with a view to commit docoity after making full preparation at Baghajatin Colony Area. Thereafter all the apprehended persons were searched and due to late night, I could not find any independent witness to be present at the time of search and seizure. During search the above noted articles were seized from their possession.

All the articles were seized on 21.10.22 between 01.40 hrs to 02.50 hrs issuing a proper seizure list duly signed by the accused persons. Thereafter all the persons were arrested with proper memo of arrest, and accordingly myself along with force with arrested accused persons returned back at Pradhan nagar P.S.

Under the above circumstances, I pray before you that a specific case may kindly be started against the arrested accused persons namely (1)Dipu Das(25) S/O- Sri Mouji Das of Sukantapally, Gas Godwan near PS-Matigara Dist-Darjeeling, (2) Bappi Paswan (19) S/O- Late Raju Paswan of Gurung Busty Loharpatti PS- Pradhannagar ,Dist-Darjeeling, (3) Sanjay Singh(19) @Patal s/o-Late Dinesh Singh of Gurung Busty Lohapatti ,PS- Pradhannagar ,Dist-Darjeeling, (4) Amar Yadav(21) @ Kancha S/O- Sri Krishna Yadav of Rajendra nagar Coolipara ,near sasan PS- Pradhannagar Dist- Darjeeling &(5)Raj Dom (19) S/O Suresh Dom of Gurung Busty Lohapatti ,PS- Pradhannagar ,Dist-Darjeeling and other and arrange for its investigation.
