I, SI Binup Mahato, of Bagdogra PS do hereby producing the arrested accused person namely Koushik Sir, Dutta (29) s/o Kamal Dutta of Dulur Chhat, Hansqua PS Bagdogra Dist. Darjeeling along with the following seized Fire crackers under proper seizure list viz;

(1) 24 (Twenty four) packets Burima chocolate Crackers, Burima Fire Works, Belur, Howrah, each packet 12

(2) 250 (Two hundred fifty) packets Fire Crackers styled King COBRA electric Crackers, SRI VIJAI, Pyrotechnic Factory, SIVAKASI, each packet 28 piece.

I SI Binup Mahato of Bagdogra PS, SPC do hereby lodged a written complaint against the above noted accused person to the effect that today on 22.10.22 at 18-25 hrs received a source information that one person have been storing and selling Fire-crackers from his shop at Dulur Chhat, Hansqua PS Bagdogra without having any license or other valid desuments violating the provision of law which may endanged auman life and likely to cause injury, accordingly I share the information to the duty officer and also O.C. Bagdogra PS which noted in GD vide Bagdogra PS GDE No. 995 dtd. 22.10.22 and as per direction of O.C. PS myself alongwith, ASI Khagen Barman C/1008 Kanak Roy, CV- 389 Janak Singh, VP-01 Ansalam Kujur, VP-02 Pradip Roy left for the spot to verify the veracity of the information and on arrival at Dulur Chhat, Hansqua PS Bagdogra at 18.55 hrs on being pointed out by the source we cordoned the said shop and called two disinterested witnesses of the locality namely (1) Monoranjan Singha (30) s/o Bimal Singha of Hansqua More PS- Bagdogra Dist. Darjeeling and (2) Ashish Ghosh (52) s/o Lt. Himanshu Ghosh of Hansqua More PS- Bagdogra, Darjeeling and held raid in that shop and apprehended one person who disclosed his name and address mentioned above and on being searched I recovered above noted fire-crackers from the possession of the said person from his shop. On demand the apprehended person failed to produce any valid documents/licenses in support of the possession of such quantity of Fire Crackers recovered. There is a reason to believe that the said person was storing and selling fire crackers which are combustible in nature and endanger to human life and property. The Fire crackers were stored without any precautionary and safety measure, Accordingly, I seized the fire crackers under proper seizure list duly signed by the witnesses and also the accused person and labeled the same in presence of witnesses. Accordingly, I arrested the above noted accused person and issued memo of arrest on the spot duly sign by him. The seizure & arrest was made in between 19-15 hrs and 20-35 hrs

Under the above circumstances I pray before you that a specific case may kindly be started against the above accused persons namely Koushik Dutta (29) s/o Kamal Dutta of Dulur Chhat, Hansqua PS Bagdogra Dist. Darjeeling under proper section of Law, to arrange for its investigation.
