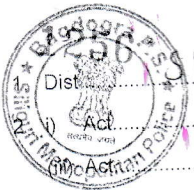

Sir,

I, SI Binup Mahato, of Bagdogra PS do hereby producing arrested one accused person namely Guddu Kumar Thakur (22) S/O Khayali Thakur of Chowpukuria PS Bagdogra Dist. Darjeeling along with the following seized Fire crackers under proper seizure list viz;

(1) Two Packets containing 15 (fifteen) Nos. Dulal's CHOCOLATE, Electric Sound Firecrackers, Chandan fire Works, SIVAKASI.

I SI Binup Mahato of Bagdogra PS, SPC do hereby lodged a written complaint against the above noted accused person to the effect that today on 25.10.22 at 14-05 hrs myself alongwith ASI Khagen Barman C/1008 Kanak Roy, LV- 389 Janak Singh, VP-01 Ansalam Kujur, VP-02 Pradip Roy were performed Spl. Evening mobile duty in c/w Kalipuja festival and also prevent to sale and bursting of firecrackers for strict implementation of order of the Hon'ble High Court, Calcutta vide Bagdogra PS GDE No. 1113 dt. 25.10.22. At 19-55 hrs while myself alongwith force arrived near Upper Bagdogra and found that one person has been bursting of firecrackers at Upper Bagdogra near Bus Stand under PS Bagdogra violating the provision of law and also direction, issued by the Hon'ble High Court, Calcutta which may endanger human life and likely to cause injury, accordingly I share the information to the duty officer and also O.C. Bagdogra PS vide Bagdogra PS GDE No. 1124 dt. 25.10.22 and as per his instruction we apprehended the above noted one person in presence of witnesses namely (1) Sontosh Kr. Thakur (32) s/o Rambilash Thakur of Promodnagar PS- Bagdogra Dist. Darjeeling and (2) Tarun Sen (26) S/O Ashok Sen of Vivekananda pally PS- Bagdogra, Darjeeling and on being searched I recovered above noted fire-crackers from his possession as he was violating of the directives of the Hon'ble Court regarding bursting of non-permitted fire crackers which are combustible in nature and endanger to human life and property. Accordingly, I seized the fire crackers under proper seizure list duly signed by the witnesses and also the accused person and labeled the same in presence of witnesses. As such I arrested the above noted one accused person and issued memo of arrest on the spot duly sign by him. The seizure & arrest was made in between 20-35 hrs and 21-05 hrs

Under the above circumstances I pray before you that a specific case may kindly be started against the above accused person namely Guddu Kumar Thakur (22) S/O Khayali Thakur of Chowpukuria PS Bagdogra Dist. Darjeeling under proper section of Law, to arrange for its investigation.
