With due respect and humble submission I, Sri Nima Gyaljen Tamang Son of late Dhan Bahadur Tamang of Sikari Dara, Debisthan, Post Office and Police Station Sukhia Pokhri Darjeeling would like to inform you that I have purchased a piece or parcel of land measuring 5 Kattahs 2 Chattaks in the name of my wife Smt. Anju Tamang by way of Deed of Sale being No. 0091 Dated 08.01.2013 and also mutated my name in the Record of Rights in the B.L. & L.R.O. Matigara and a Khatian is been opened in my name vide Khatian No. 1320 in Mouza Chamta, J.L. No. 26, in L.R. Plot No. 223 Corresponding to R.S. Plot No. 185 recorded in Old Khatian No. 45.

Sir, I along with other 13 purchasers have purchased small plots of land from the legal heirs of Late Kandra Munda Through their Attorney Shri Kamal Munda Son of Late Malu Munda of Helapokhri vide his General Power of Attorney Being No. IV- 720/14.09.2012 and the land was

totally boundary wall and we all took the possession of the land and demarcated our small plots with small cemented boundary.

Sir, we have come to know that the above named persons SONAM DOMA BHUTIA Wife of MING DORJEE LAMA, Chewang Damdu Lama, Son of Tamding Narbu Lama of Darjeeling came along with 20-25 persons few days back as holiday was going around and we were busy with our festivals in Darjeeling and by force broke the lock of the boundary wall and also damaged all our demarcation and also took away iron ods, cement bags etc etc and tried to encroach the land. They came with hockey sticks iron rods and other weapons and also threatened us that it is their land and they have purchased from Kandra Munda but did not showed any Deed of Sale. We all searched in the registration office and procured two Deed of Sale in favour of Smt. Sonam Doma Bhutia executed by one Kandra Munda vide Deed no. 1044/1993 and other in favour of Smt. Chewwang Damdu Lama and Tamding Norbu Lama executed by same Kandra Munda vde Deed of Sale being No. 2090/1993. When we procured this document we thought there is a foul play with us and we all went to the legal heirs of Kandra Munda and showed them these Deed of Sale and charged them that why did they sell us the land which was already sold by their father at that instance the legal heirs of Kandra Munda handed over us the DEATH CERTIFICATE issued by Sub-Registrar Birth and Death Pattharghatta Gram Panchayat vide Certificate No. 213 which clearly mentioned that KANDRA MUNDA died on 05.06.1990 . Hence when we enquire the matter locally we came to know that the documents was all forged by the abovementioned person with the help of some local influential people just to grab our land illegally and make illegal gain by selling it to another persons.

Therefore Sir, Kindly enquire the matter with serious concern as I have spent my entire life savings to purchase this land in a view to build a small house for my post retirement time but since in Siliguri there are lot of Land Mafias who like this forged the documents and make fake Deed of Sale and try to manipulate the Concern B.L.&L.R.O. to make fake Khatians by deceiving the Office and not disclosing that whether the person who have executed the Deed if original or not.

Therefore Sir kindly take strict action against such persons abovementioned who are involved in these kind of illegal encroachment of land, forging the documents, breaking up the boundary lock and stealing the construction rods and cement and also according and as per law for ends of justice.
