I, SI- Newton Biswas of New Jalpaiguri Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned accused persons namely i) Subash Barai s/o Lt Tarachand Barai of Joynagar Colony, PS-NJP, Dist.- Jalpaiguri (ii) Subash Sarkar s/o Sudarshan Sarkar of Joynagar Colony, PS- NJP, Dist.- Jalpaiguri (iii) Rinku Sarkar of s/o Jitendar Sarkar of Joynagar Colony, PS- NJP, Dist.- Jalpaiguri to the effect that today on 24.10.2022 at 21.55 hrs Myself along with force namely HG/794-Ranjit Roy, CV/116-Rohit Kumar Mahato, CV/306 Biswajit Roy, CV/824 Niru Kumar Yadasv all of New Jalpaiguri PS, Slliguri Police Commissionerate performing Night PC van duty under New Jalpaiguri PS, Slliguri Police Commissionerate. This refer New Jalpaiguri PS GDE No.1096 date: 24.10.2022. While performing PC van duty at Shaktigarh area we found that the above noted accused persons was obstructing the main road and brusting fire crackers by violating the government Rules and Norms and violating the provision of Law which may endanger human life.
