Accordingly, I informed the fact the Officer-In-Charge, NBMC Out Post under Matigara PS, SPC and requested him to send more police personnel at near Selim ghat under Matigara PS, SPC. At 01.25 hrs ASI Anupam Roy, ASI Krisnendu Roy C/340 Pranab Adhikary, CV/158 Partha Sarkar all of NBMC Out Post under Matigara PS, SPC arrived at Selim Ghat and accompany with us. At about 01.45 hrs as indicated by the source we noticed that 11/12 persons assembled in a dark place at Selim Ghat beside Balasan River under PS- Matigara, Dist.-Darjeeling and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 05 (five) of them with deadly weapons in their possession but 05/06 persons managed to fled away taking the advantage of darkness. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally
