In producing herewith two arrested accused persons namely (1) Fuleshwari Singh(40) W/O- Anadi Singh of Sir, Baribhasa near Madani Bazar, P.S: NJP, Dist- Jalpaiguri (Not Verified) and (2) Leshmi Basak (28) W/O- Sujit Basak of Baribhasa near Madani Bazar, P.S: NJP, Dist-Jalpaiguri (Not Verified) along with the following seized articles under

i) One Packet containing 8 kgs 139 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown seizure as per seizure list: colour cello tape and marked as "Exhibit-A' Out of which 100 grams taken as sample and marked as "Exhibit-A-1". ii) One Packet containing 08 kgs 246 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-B" out which 100 grams taken as sample and marked as "Exhibit-B-1".

iii) One Packet containing 08 kgs 200 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown

colour cello tape and marked as "Exhibit-C" out which 100 grams taken as sample and marked as "Exhibit-C-1". iv) One Packet containing 03 kgs 107 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-D" out which 100 grams taken as sample and marked as "Exhibit-D-1".

V) One Packet containing 03 kgs 135 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-E" out which 100 grams taken as sample and marked as "Exhibit-E-1".

VI) One Packet containing 03 kgs 069 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-F" out which 100 grams taken as sample and marked as "Exhibit-F-1".

VII) One(01) Black and Ash coloured hand bag styled as "ELLE PARIS" wherein kept Exhibit-A and marked as "Exhibit- G"

VIII) One(01)Pink and blue bordered hand bag styled as "ELLE" wherein kept Exhibit- B and marked as "Exhibit- H" IX) One(01)Blue and black bordered hand bag styled as "ELLE" wherein kept Exhibit-C and marked as "Exhibit-I" X) One(01)Peach, Blue, Ash and black bordered hand bag styled as "www.Lifeok.com jbc" wherein kept Exhibit-D and

marked as "Exhibit-J"

XI) One(01)Light green, white and black bordered hand bag styled as "www.Lifeok.com jbc" wherein kept Exhibit-E and marked as "Exhibit-K"

XII) One(01)light yellowish and maroon in colour Polycotton shopping bag written Bengali, styled as "Mira Sari house" wherein kept Exhibit-F and marked as "Exhibit-L"

I, L/SI Sunanda Sonar of Pradhannagar Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against ((1) Fuleshwari Singh(40) W/O- Anadi Singh of Baribhasa near Madani Bazar, P.S. NJP, Dist-Jalpaiguri (Not Verified) and (2) Leshmi Basak (28) W/O- Sujit Basak of Baribhasa near Madani Bazar, P.S: NJP, Dist- Jalpaiguri (Not Verified)to the effect that on today on 05/11/2022 at about 20:05hrs. I received a specific source input that two ladies are waiting suspiciously in front of Loknath bus service near Siliguri Tenzing Norgey Bus Terminus under PS Pradhanagar with handbags containing huge consignment of Ganja in order to supply the same to their design customers for their wrongful gain .The matter was diarized vide Pradhannagar P.S. GDE No-295 Date-05/11/2022. Accordingly, I informed the matter to the Inspector -in-Charge of police, Pradhannagar Police Station in writing a letter to him and expressed the entire information. As per his kind direction myself along with SI Shibdhan Karmakar, C/762 Majibul Rahaman and CV-992 Jagadish Biswas, CV 128 Ajay Kumar Sahani, CV 223 Swapan Chhettri and LC/1269 Pramila Chhettri all of Pradhannagar Police Station, Siliguri Police Commissionerate left for Siliguri Tenzing Norgey Bus Terminus under PS- Pradhannagar by Govt. vehicle to verify the veracity of the information vide Pradhannagar P.S. M.C.C. No- 2336/22 date 05/11/2022. This refers to Pradhannagar P.S. GDE No-296 date 05/11/2022.

At the time of departure from the Police station I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metrology department) etc. At about 20:35hrs we arrived near Loknath Bus service in near Tenzing Norgay Bus stand under PS- Pradhannagar and way to Loknath Bus service I called two independent witnesses namely (a) Ashok Rai S/O Lt Milan Rai of Tadong Metro point Ranipool, P.S: Ranipool, East-Sikkim at present Durga Hotel, Siliguri Junction, P.S: Pradhanagar, Siliguri, Dist: Darjeeling and (b) Rabi Kurmi S/O Lt Ram Prasad Kurmi of New Alipore Railway Station, P.S: Alipore, Dist: Alipurduar and at present Bishnu hotel Siliguri Junction, P.S- Pradhanagar Dist- Darjeeling who were present there and disclosed our identity and informed them in writing letter about the information in hand and requested them to accompany us in the whole process during search and seizure if necessary. Accordingly, they have given their verbal consent. As identified by the source we found that two ladies standing in front of Loknath Bus Service near Tenzing Norgey Bus Terminus with six(06) different coloured handbags. Among them one lady carried three(03) bags and another lady carring three(03) bags. Accordingly we apprehended the above noted ladies and cordoned along with their bags. On being asked by me, they disclosed their name and identity as noted above.

After disclosing our identity, we detained the above noted ladies with a strong reason to believe that they have illegally possessing ganja inside their bags, which they were carrying for supplying the same to their designed customers for their wrongful gain. On being asked they confessed that they have possessed ganja in their bag for supplying the same to their designed customers as per requirement and they were waiting there for transportation to Bihar. I then gave them option

then gave them option whether they wanted to be searched in presence of the Executive Magistrate or by any Gazetted Officer. Then they agreed to be searched by one of them. Further I served them a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the accused persons to search our Police Party as per provision. But they refused to search the police party. Thereafter I informed the matter Sri Anirban Bhattacharjee, I/C, Pradhnagar P.S. and as per his kind order I informed the matter Sri Manish Yadav, WBPS, Assistant Commissioner of Police (West Zone), Siliguri Police Commissionerate who has been detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessing of ganja and requested him to come at Loknath bus service near Tenzing Norgey Bus Terminus under Pradhannagar P.S. to remain present and to supervise the search and seizure being the Executive Magistrate. Accordingly at 21:45hrs Sri Manish Yadav, WBPS, Assistant Commissioner of Police (West Zone), Siliguri Police Commissionerate arrived at the spot in uniform and disclosed his identity to the detained persons as well as witnesses as Executive Magistrate and in presence of two independent public witnesses search was conducted of the detained ladies following all formalities keeping their decency but nothing could be recovered from their physical possession except wearing apparels as mentioned above. Then I conducted search of the bags which they were carrying and found the above noted seized articles which were kept inside the said bags. On demand in presence of the Executive Magistrate Sri Manish Yadav, WBPS, Assistant Commissioner of Police (West Zone), Siliguri Police Commissionerate they failed to produce any valid document in support of possessing of the ganja which were kept inside their bags.

I accordingly weighted the Ganja by the weighing instrument of Pradhannagar P.S. SPC and found weight of each packet which are as follows: i) One Packet containing 8 kgs 139 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-A' Out of which 100 grams taken as sample

and marked as "Exhibit-A-1".

ii) One Packet containing 08 kgs 246 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-B" out which 100 grams taken as sample and marked as "Exhibit-B-1".

iii) One Packet containing 08 kgs 200 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-C" out which 100 grams taken as sample and marked as "Exhibit-C-1".

iv) One Packet containing 03 kgs 107 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-D" out which 100 grams taken as sample and marked as "Exhibit-D-1".

V) One Packet containing 03 kgs 135 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-E" out which 100 grams taken as sample and marked as "Exhibit-E-1".

VI) One Packet containing 03 kgs 069 grams of said to be "Ganja" wrapped with brown colour Polythin paper and brown colour cello tape and marked as "Exhibit-F" out which 100 grams taken as sample and marked as "Exhibit-F-1". (Total 33 Kg. 896 grams).

Accordingly I packed, sealed, labeled and seized the above noted consignment said to be ganja, and bags from their joint possession at the spot at Loknath Bus service near Tenzing Norgey Bus Terminus under Pradhannagar P.S. under proper seizure list in presence of independent witnesses and Sri Manish Yadav, WBPS, Assistant Commissioner of Police (West Zone), Siliguri Police Commissionerate obtaining their signature and being acknowledge by the accused persons. The whole process of search and seizure has been videographed as per provision of law. The seizure was made between 22:25 hrs to 23:15hrs. On further interrogation the apprehend ladies confessed in presence of Sri Manish Yadav, WBPS, Assistant Commissioner of Police (West Zone), Siliguri Police Commissionerate and other witnesses that they procured the Ganja clandestinely from Coochbehar area for the purpose of selling the same in high rate to their designed customers at Muzzffarpur, Bihar for their personal gains by illegal means. On interrogation they disclosed that they have been dealing in such business of selling the ganja illegally since last few months.

Then I arrested the above noted accused persons after observing all guidelines of Apex court as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. Thus arrested accused ladies named (1) Fuleshwari Singh(40) W/O- Anadi Singh of Baribhasa near Madani Bazar, P.S: NJP, Dist- Jalpaiguri (Not Verified) and (2) Leshmi Basak (28) W/O- Sujit Basak of Baribhasa near Madani Bazar, P.S: NJP, Dist- Jalpaiguri ( Not Verified) have violated the terms and conditions of Narcotic Drugs for possessing Ganja without any valid authority & license. Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person named ((1) Fuleshwari Singh(40) W/O- Anadi Singh of Baribhasa near Madani Bazar, P.S: NJP, Dist-Jalpaiguri (Not Verified) and (2) Leshmi Basak (28) W/O- Sujit Basak of Baribhasa near Madani Bazar, P.S: NJP, Dist-Jalpaiguri (Not Verified) and arrange for its investigation.
