4. One Iron made "**Hammer**" having length 3"5' Inch (approx.) including Iron butt having length 9"5' recovered from the possession of Hassan Raja @ Subrata.
5. One Iron "**rod**" having length 25' Inch (approx.) recovered from the possession of Chand Sharma.
6. One iron rode measuring length 4 ft. (approx) recovered from the possession of Shiva Chettri.
7. One torch light and one Sward measuring 30 inches including wooden butt recovered from the possession of Gopal Karmakar.

I, SI Sibdhan Karmakar of Pradhannagar P.S, SPC would like to lodge this written complaint against the above noted accused persons and others to the effect that on 11.11.22 at 00.25 hrs while myself along with force were performing night patrolling duty at that time I received a source information that 12/14 persons were assembled at Dagapur tea Garden under Pradhan nagar P.S. area with deadly weapons with a view to commit some heinous crime. This refers to Pradhannagar P.S GDE No- 699 date 11/11/2022. Accordingly, I inform the matter to you and as per your kind instruction myself along with ASI Ashit Singha, CV/992 Jagadish Biswas, CV/645 Pankaj Gupta, CV/223 Swapan Chettri, CV/128 Ajay Kr Sahani and CV-646 Babn Das took departure for the spot. We reached near the spot as confirmed by the source and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. At about 00.45 hrs we reached at Dagapur tea Garden under Pradhan nagar P.S and found a group of 12/14 persons assembled and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately, one of the people among the gang saw us and

multiple directions. Somehow, after a hot chase we could able to apprehend the above noted 07(seven) persons.

On interrogation they disclosed their identity noted above and also stated that they along with other associates with them had assembled there with a view to commit dacoity after making full preparation at Dagapur Area . Thereafter all the apprehended persons were searched and due to late night, I could not find any independent witness to be present at the time of search and seizure. During search the above noted articles were seized from their possession.

All the articles were seized on 11.11.22 between 01.55 hrs to 02.35 hrs issuing a proper seizure list duly signed by the accused persons. Thereafter all the persons were arrested with proper memo of arrest, and accordingly myself along with force with arrested accused persons returned back at Pradhan nagar P.S.

Under the above circumstances, I pray before you that a specific case may kindly be started against the arrested accused persons namely (1) Akash Tamang (26) S/O- Palden Tamang of Chowrasta , Darjeeling PS- Sadar , Dist- Darjeeling ,(2) Nima Sherpa (28) S/O- Late Jai Bahadur Sherpa of Near Sonada Petyrole Pump , PS- Jorebunglow Dist- Darjeeling , (3) Khokan Mahato (25) S/O- Late Bablu Mahato of Champasari Anchal Dhaknikata , PS- Pradhannagar Dist- Darjeeling ,(4) Hassan Raja @ Subrata (22) S/O- Alauddin Mahammad Mallaguri Ratanlal Busty , PS- Pradhannagar , Dist- Darjeeling ,(5) Chand Sharma (19) S/O- Late Sapil Sharma of Mallaguri Ratanlal Busty PS- Pradhannagar Dist- Darjeeling (6) Shiva Chettri (21) S/O- Late Suresh Chettri of Marik Sourini bazaar PS- Mirik , Dist- Darjeeling and (7) Gopal Karmakar (22) S/O- Late Bimal Karmakar of Pati Colony Road No-3 PS- Pradhannagar Distr- Darjeeling and others and arrange for its investigation.
