Respected Sir,

I, the undersigned would like to bring this to your kind attention that one Sri Amit Chaudhary, Son of Sri Bhairav Kant Chaudhary, resident of Isckon Mandir Road, Sarat Chandra Pally, under Bhaktinagar Police Station, District: Jalpaiguri being my agent was entrusted with selling of TMT Bars to different customers all over North Bengal region and adjoining areas including Sikkim. For last few days I could notice that several customers who use to purchase TMT Bars from my concern are not clearing their dues and to that effect I on 11.11.2022 at around 11.00 am called the owner of 'Disha Trading' and after conversation with the said person it came to my notice that no amount whatsoever was due from him whereas my ledger prepared by the aforesaid accused person Sri Amit Chaudhary was showing a due of Rs. 2,60,374/-. On further grilling it came to our knowledge that there are several other customers whose ledger statement are showing outstanding amounts but the customers have not received such goods as reflected in the ledger account. After proper enquiry it got revealed that the aforesaid accused person have forged bills / invoices to the tune of Rs. 7 Crores (approx.) as revealed till date and have sold the materials elsewhere and have received cash amount against such sale. On further enquiry the accused person Sri Amit Chaudhary confessed that in connivance with Mohan Jhawar (Mobile No. 9434106781), Fulbari Hardware Store, Muzzamil Hussain (Mobile No. 7001291517), Rahman & Hussain, Babul Rashid, Hazra Khatoon, Hussain Enterprises and others as confessed by Sri Amit Chaudhary hatched up a conspiracy to misappropriate such amount of TMT Bars and thereby forging valuable security to receive money dishonestly and thereby committed criminal breach of trust. The aforesaid accomplice in this case, i.e., Mohan Jhawar (Mobile No. 9434106781), Fulbari Hardware Store, Muzzamil

Hussain (Mobile No. 7001291517), Rahman & Hussain, Babul Rashid, Hazra Khatoon, Hussain Enterprises and others are habitual in dealing with stolen properties and the accused persons gaining access to our office through accused Sri Amit Chaudhary misappropriated goods worth Rs. 7 Crore (approx.) (revealed as of now). We are expecting that this amount could reach upto the tune of Rs. 8 Crore or more after a thorough investigation is done in this matter. Moreover the accused person Sri Amit Chaudhary has forged the bills as genuine to gain our confidence thereby falsifying accounts for the purpose of cheating.

The accused Amit Chaudhary being an agent of M/S Shree Shyam Udyog has forged accounts, bills and ledgers and portrayed them as genuine for the purpose of cheating and thereby entering into criminal conspiracy with the aforesaid accused persons siphoning out amount to the tune of Rs 7 Crores (approx.). I believe that there are other accused persons who are hand in gloves with this accused person Amit Chaudhary and the same could be revealed after investigation.

I therefore pray before your kind office to treat complaint as F.I.R. and to further intervene into this matter and take strict action against such accused persons.
