Sir,

In producing here with two letters received from (1) Ankit Kaul, Deputy Director, Directorate of Revenue Intelligence, Siliguri Regional Unit, Siliguri vide memo no- DRI F No- 07/CL/IMP/DRI/SLG/2022-23/990 Dt-09.09.2022 regarding complaint against two(02) suspected Mynmar Nationals Tlangmuanthanga and Dal Suan Khai arrested in smuggling of gold of foreign origin-reg and another letter received from (2) Superintendent, Siliguri Special Correctional Home, Siliguri vide no- 3061/AB dt-10.11.2022 regarding unauthorised Foreign Nationals(Mynmar nationals) lodged at Siliguri Special Correction Home w.e.f 05.09.200 in connection with CR Case No- 1015/22 U/S- 104 of Customs Act 1962, I SI Upen Chettri of Siliguri PS, SPC do here by lodged a written complaint against Tlangmuanthanga and Dal Suan Khai, Myanmarese Nationals to the effect that on 04.09.2022 two Myanmarese Nationals namely Tlangmuanthanga and Dal Suan Khai apprehended by them with smuggled gold concealed in their shoes. On interrogation they came to know that the above noted persons illegally entered in India without any valid Pass Port or Visa on 01.09.2022 through Rikhawdar-Zokhawthar of the Indo- Myanmar border carrying smuggled gold. On interrogation they also came to know that the above noted accused persons confessed before them their Epic cards are fake which was they produced before them and they illegally entered in India without any valid documents. They also confessed that their actual name and address is Tlangmuanthanga S/O-Thabilthuana of Sagaing, Kalaymyo, Vill – Kyutumpin, Myanmar and Dal Suan Khai S/O- Shri Thang Suan Mang of Kalaymyo(Kalay), Taungphylar, Sagaing, Myanmar and presently both the persons are in judicial custody in Siliguri Correctional Home in c/w CR Case No-1015/2022.

I therefore pray before your honour a specific case may kindly be initiated under proper section of law and arranged for its investigation.
