With due respect , I, SRI DURGESH SINGHA, Son of Late Ashiram Singha, resident of Badlavita, , P.O.New Champta, P.S.Matigara, Dt. Darjeeling, would like to inform you that my father Late Ashiram Singha was the sole absolute owner of land measuring about 55 decimal in R.S.plot 97 &89 corresponging to L.R. plot 331 (36 decimal) and 316(19 decimal) by virture of a registered sale deed being no.1-2398 in the year 1962 executed by Fataswari Bewa, wife of Buran singh of Chotomohansinghjote. After elapsing three years in the year 1965 my father sold out land measuring 36 decimal of land in plot no.97(R.S)corresponding to L.R plot no.331 to one Sri Anil Singha, Son of Late Dhima Singha of Amarpally, Phansidewamore out of his aforesaid purchased land .My father also had piece of separate land measuring about 42 decimal connected with the aforesaid purchased land in 96(R.S) corresponding to L.R plot no.332 in khatian no.8/20(R.S) situated at Mouza Jitu, J.L. no 69 which he inherited from his ancestor and had sold out land measuring 24 decimal during his life tme. Now the residue land measuring 18 decimal is still lying in my father's khatian vide no.24(L.R). After the demise of our father I include my mother and three sisters and three brothers have became the joint owners of land measuring about 18 decimal as left by our father according to the provision of hindu law of inheritance.
