On reaching there and as identified by the source it found that one person Abhimunya Chhetri was selling and storing liquor at Jyoti Nagar more under Bhaktinagar PS. Subsequently, I along with my force cordoned the place and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted place seized articles were found at that place.
