Sir,

In producing herewith one (01) arrested accused person namely Md Aslam (24) s/o Md Aptaddin of Totaramjote PS Naxalbari Dist. Darjeeling alongwith following seized articles viz,

- i. One thin plastic packet in contents 402 ( Four hundred two) grams said to be brown sugar ( Heroin) as mother packet , Marked as Exhibit- A from which taken 21 grams said to be Brown sugar ( Heroin) in a thin plastic packet as sample for examination, Marked as Exhibit -A1
- ii. One Pittu Bag , black colored in which written Skybags which was used to carry the above noted seized articles.
- iii. One Motorcycle styled as Hero Glamour XTEC , black colour without number plate.

I, SI Raju Chettri of Bagdogra Ps , Siliguri Police Commissionerate do here by lodged this complaint against the above noted accused person to the effect that on 20.11.22 at 16-45 hrs received a secret source information that two persons with black colour Motorcylce without number was coming towards Siliguri from Naxalbari side with huge quantity of brown sugar for clandestinely disposal of the same illegally and informed the matter to duty officer of PS. The matter was diarized vide Bagdogra Ps GDE No- 902 dt- 20.11.22. Accordingly, I informed the matter to O.C, Bagdogra PS as per his instruction myself along with SI Binup Mahato, ASI Khagen Barman , C/1008 Kanak Roy , VP- 02 Pradip Roy, CV-389 Janak Singha left for the spot at 16-55 hrs to verify the veracity of the information vide corresponding Bagdogra PS G.D.E. No. 903 dtd 20.07.22 and Bagdogra PS M.C.C No- 4155/22 Dt.20.11.22.

At the time of departure from Police Station I bring spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal, emergency light etc . On way meanwhile I called two independent witnesses namely 1. Ranjit Barman (38) s/o Lt. Shantiram Barman of Kestopur, Chowpukuria PS Bagdogra Dist. Darjeeling and 2. Ashok Biswas (39) s/o Krishna Biswas of Kestopur, Chowpukuria PS Bagdogra Dist. Darjeeling informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. At about 17-25 hrs on arrived at Janglibaba Mandir More by Govt. vehicle bearing No. WB-68-Q-6401 and started Spl. Naka checking to upcoming all Motorcycle and on identified by the source we gave signal to stop one black colour Motorcycle, but on seeing police said Motorcycle try to flee away from there, on hot chase we somehow managed to detained the said Motorcycle without number plate with Motorcycle rider who was carry one Pittu Bag but one of his partner managed to flee away from there. On being asked he disclosed his identity as noted above and also disclosed the name of his partner namely Md Sultan of Naxalbari who fled away from the spot . After disclosing our identity I asked him whether he wanted to be searched himself in presence of Executive Magistrate or any Gazetted Officer because we have information that you are carrying huge drugs like brown sugar and he agreed to search by any one. I served him option notice accordance with provisions of law in this regard in writing and he also gave his approval of being searched by any one in writing in the notice serve to him. Accordingly I informed the matter to O.C. Bagdogra PS and he informed me over mobile phone to send one requisition to Sri Gyalsen Lepcha, ACP, (Traffic HQ), SPC . Accordingly I informed to Sri Gyalsen Lepcha, ACP, (Traffic HQ), SPC and request to came to the spot through one C/1008 Kanak Roy. At about 18-25 hrs Sri Gyalsen Lepcha, ACP, (Traffic HQ), SPC and O.C. Bagdogra PS arrived at the spot. I disclosed the identity of Sri Gyalsen Lepcha, ACP, (Traffic HQ), SPC to the accused person as Gazetted officer and also witnesses. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But they refused to search the police party. Under supervision of Sri Gyalsen Lepcha, ACP, (Traffic HQ), SPC and in presence of independent witnesses I conducted searched and recovered one thin plastic packet in contents said to be brown sugar which was kept in his Pittu Bag which he was carrying . On demand in presence of the Gazetted Officer Sri Gyalsen Lepcha, ACP, (Traffic HQ), SPC the apprehended person failed to produce any valid documents in support of possessing of the same and also failed to produce any documents in support of the said Motorcycle.

I accordingly weighed the recovered said to brown sugar (Heroin) by the weighing instrument and found one thin plastic packet in contents said to be brown sugar approx weight 402 grms (Four hundred two) Marked as Exhibit -A from which taken 21 grams said to be Brown sugar ( Heroin) in a thin plastic packet as sample for examination, Marked as Exhibit -A1. Accordingly I seized the above noted articles

under proper seizure list and labeled and sealed all the articles in presence of Sri Gyalsen Lepcha, ACP, (Traffic HQ), SPC and independent witnesses and accused person duly signed by them and the Gazetted officer Sri Gyalsen Lepcha, ACP, (Traffic HQ), SPC and acknowledged by the accused person. On further asked the apprehend person confessed in presence of Gazetted Officer Sri Gyalsen Lepcha, ACP, (Traffic HQ), SPC and other witnesses that he alongwith his partner Md Sultan procured the said brown sugar clandestinely from one Pralay Chowdhury @ Bittu SK s/o Birendra Nath Chowdhury of Pardiatala, Jodupur, Malda for the purpose of supplying the same to their associates namely (1) Tammanna of Sontoshinagar Colony, Jhankar More, Burdwan Road, Siliguri and (2) Sova Roy w/o Uttam Roy of Durga Nagar, Iscon Mandir Road, Ward No. 41, Siliguri for the purpose of selling the same to their designated customers in order to earn huge money illegally around Siliguri area jointly. Then I arrested the above noted accused person u/s- 41 Cr.P.C after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest. The copy of seizure list and Memo of Arrest has been supplied to above noted accused person under proper receipt as the accused person violated the terms and condition of NDPS Act. The seizure and arrest was made between 18-35 hrs to 19-25 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused person namely (1) Md Aslam (24) s/o Md Aptaddin of Totaramjote PS Naxalbari Dist. Darjeeling (2) Md Sultan of Naxalbari (3) Pralay Chowdhury @ Bittu SK s/o Birendra Nath Chowdhury of Pardiatala, Jodupur, Malda (4) Tammanna of Sontoshinagar Colony, Jhankar More, Burdwan Road, Siliguri and (5) Sova Roy w/o Uttam Roy of Durga Nagar, Iscon Mandir Road, Ward No. 41, Siliguri and arrange for its investigation.
