With due respect, I am producing herewith the arrested accused persons namely (i) Bikram Haldar (26) s/o Ratan Haldar of Kamrangaguri, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Dingal Thakur (19) s/o Ram Thakur of Mina Bazar, Maharajpur, PS-Taljhari, Dist.- Sahebganj, Jharkhand, A/P.-Kachagali, Near Netaji More, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Munna Md. (19) s/o Gulap Hussian of Rupchandra Gach, PS- New Jalpaiguri, Dist.- Jalpaiguri (iv) Abu Sahib (27) s/o Tahamidul Haque of Sardarpara, PS-Rajganj, Dist.- Jalpaiguri and the following articles under seizure :-

I, ASI Sajal Das of NJP PS, Siliguri Police Commissionerate beg to state that on 21.11.2022 at 0205 Hrs I received a secret source information that a gang of miscreants come to below Thakurnagar, near Thangbanga More, under PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Thakurnagar, near Thangabanga More, Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 953 dated 21.11.2022. As per kind order and direction of my superior officer myself along with VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy, CV/116 Rohit Kr Mahato and CV/824 Niru Yadav left for Thakurnagar, , Thengbanga More, under New Jalpaiguri PS, Siliguri Police Commissionerate to work out the information in hand. I also informed the fact to night RT Van officer SI Pintu Ghosh of New Jalpaiguri PS, Siliguri Police Commissionerate and directed him to come to Thakurnagar, at Thangbanga More to accompany with us during Raid. At about 0315 hrs on 21.11.2022 we arrived at Thakurnagar, near Thangbanga more under New Jalpaiguri PS. After a few time night RT van officer SI Pintu Ghosh of New Jalpaiguri PS, SPC along with force came to Thangbanga More, Thankunagar and accompany with us. At about 0345 hrs we found that 10/11 persons assembled in a dark place at Thakurnagar near Thangbanga More and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (Four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. On search of the apprehended accused persons I found (i) One Bhojali, One Blunt Iron Rod & One Hammer from the possession of accused Bikram Haldar (26) s/o Ratan Haldar of Kamrangaguri, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) One sharp cutting Sabol and Blunt Iron Rod from the possession of accused Dingal Thakur (19) s/o Ram Thakur of Mina Bazar, Maharajpur, PS-Taljhari, Dist.- Sahebganj, Jharkhand, A/P.-Kachagali, Near Netaji More, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) One Iron made sabol, One Torch Light measuring 45 Inch from the possession of accused Munna Md. (19) s/o Gulap Hussian of Rupchandra Gach, PS- New Jalpaiguri, Dist.- Jalpaiguri (iv) One iron made Hasua, Screw Driver, one Torch Light from the possession of accused Abu Sahib (27) s/o Tahamidul Haque of Sardarpara, PS-Rajganj, Dist.- Jalpaiguri.

ng further interrogation they admitted their guilt and disclosed that they are assembled at below More under New Jalpaiguri PS, Dist.- Jalpaiguri and making preparation for committing dacoity gar and Baribhasa under New Jalpaiguri PS. Accordingly, I seized the above noted weapon of er proper seizure list and arrested the above noted 04 (Four) accused persons under proper est and observing all the formalities of arrest and brought them to NJP PS. The search seizure, rest made in between 0335 hrs to 0415 hrs on 21.11.2022.
