I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India (IO here by lodge this complaint against 5mt Sanjeeta Sharma (ph.no- 9934774363), W/O Sri Sandeep Sharma, resident of Ground Floor Flat, Sugan Mansion, Pranami Mandir Road, P.S. Siliguri, Dist- Darjeeling, Pin- 734011 & Sri Dilip Sharma (ph no- 9434044341), S/O not known, Owner of the Flat having address of Ground Floor Flat, Sugan Mansion, Pranami Mandir Road, P.S Siliguri, Dist- Darjeeling, Pin- 734011. While on a routine inspection on the site of Smt Sanjeeta Sharma in the address being Ground Floor Flat, Sugan Mansion, Pranami Mandir Road, P.S. Siliguri, Dist- Darjeeling, Pin- 734011, I, Suman Sengupta, Divisional Engineer & Station Manager, Power House CCC along with Sri Sanjay Prasad , Sr O.E, Power House CCC, WBSEDCL and other technical staffs observed that the terminal seal of the meter was broken and energy was being used bypassing the defective energy meter.

We entered the premises at 1255 hrs on 01.12-2022 after handing over Notice to Smt Sanjeeta Sharma, W/O Sri Sandeep Sharma who is residing in the above mentioned premises and was enjoying the un authorized power. Then it was observed that the power was being used in an unauthorized manner via directly bypassing the mechanical energy meter and breaking the terminal seal of the energy meter via direct tapping from the service cable. It was further observed that the meter was deemed disconnected as well as defective at the moment. Therefore committing a crime for theft of power as per section 135 (1) (b) of the Indian Electricity act 2003 amended on 2007. Load of 3nos of the Indian Electricity act 2003 amended on 2007. tube lights, 1nos of bulb, 3nos of ceiling fans and 1nos of fridge was found which totals to 1500watts or 1.5kw or 1.76Kva. Accordingly the connection was disconnected and the energy meter and service cable were seized and labelled. A copy of both inspection report and Seizure list (1. Genus Overseas Electronics Limited make, 1 Phase, (240 Volts), (5-30) amps, SI No GS360097, property of WBSEDCL, & 2. Service Cable of White Color,6 Sq mm, Single Stranded wire of 2 meters approx) were handed over to Smt Sanjeeta Sharma. It was also found that Sri Dilip Sharma, owner of the flat was aware of the fact that the power was being used in an unauthorized manner in the premises, but made no attempt to rectify the same. We exited the premises on 1325hrs.

Thus you are requested to kindly initiate an investigation against Smt Sanjeeta Sharma under Section 135 (1) (b) of the Indian Electricity act 2003 amended on 2007 of India and Sri Dilip Sharma under Section 150 of the Indian Electricity act 2003 amended on 2007 of India
