Most Humbly I, Sri Ravi Choudhury S/o Late Jogendra Choudhury resident of Shardha Mani Plaza, sevoke road, Siliguri, Ward No. 10 of S.M.C, P.S Siliguri, Dist Darjeeling do hereby lodge this written F.I.R to the effect stating that 1) Md Nosad Alam S/o Hussain Vakas 2) Md. Badruddin S/o Maniruddin 3) Md. Sakir Alam S/o Hasiuddin all resident of Nikarbari, Sabudangi, Police Station Kadogaon, Dist Kishanganj in the state of Bihar, all representing themselves as partner of M/S- Bharat Bricks approached me and asked me for loan of Rs 5,50,000/- for the purpose of investment in their bricks manufacturing buisness as they knew about the fact that I also deal in selling Bricks. Those three persons also represented/ promised me that this amount will be returned by March 2022 after the end of brick manufacturing season and they also promised me that in the event that they will not be able to return the money then they sell deliver bricks to me of that amount.

Being deceived by their false representation and promised I paid Rs 5,50,000/- in total through R.T.G.S. On date 02/09/2021 I paid Rs 2 lakhs, on 24/09/2021 I paid Rs. 1 lac, on 01/10/2021 I paid Rs 1 lac, on 06/11/2021 I paid Rs 1 lac and last payment of Rs 50,000 was paid on 18/12/2021 and in this manner I paid Rs 5,50,000/- in total jointly to them in their partnership firm bank account.

After receiving this amount all the three persons have not returned back the amount of Rs 5,50,000 /after the end of March 2022 and on several times I have requested all of tem to returned he money or in the alternative delivered to me 1,37,500 pieces quantity of bricks in lieu of Rs 5,50,000/- but all of them have refused to either return the money and/or deliver bricks to me of that amount

From the very beginning the three persons had bad intentions and due to such reason all three of them fraudulently made false representation to me wih the intention of cheating and deceiving me and I being deceived by their false representation delivered the amount of Rs 5,50,000/- to them, had I not been deceived by their false representation I would not have paid this amount to them.

Now they have refused to return back the money so they have cheated me and misappropriated the total amount for their own use causing wrongful loss to me.

Hence I pray before you to kindly registered this complaint as F.I.R and take necessary action against all the above name accused persons and recover my hard earn money from them.
