(iii) Two pieces cream coloured athletics kneecap marked as "Exhibit-C, (iv) One white coloured keypad phone styled as Kabonn having IMEI No. 359385105799714 & 359385106769716 and having contact No. 7260879887 marked as "Exhibit-D, (v) One black coloured keypad phone styled as Kabonn having IMEI No. 911649158839268 & 911649158839276 and having contact No. 7654946539 marked as "Exhibit-E, (vi) One EPIC card vide EPIC No. IWG0679217 of Rajakumar Ram S/O Khanehar Ram of Sasaram Town/Vill.-Sasaram Anchal/Thana- Udwaninagar, Dist. Bhojpur-802157 marked as "Exhibit-F and (vii) Cash Rs. 6400/- in denomination of Rs. 500x9, Rs. 200x7, Rs.50x10.

I, SI Koushik Ghosh of STF, WB do hereby lodge a suo-moto complaint that on 29/11/2022 as per direction of Insp. Sankar Chowdhury, O/C Narcotic, STF WB a team consist of ASI Jahangir Alam, C/142 Ratan Bhunia, C/128 Golam Muftafa, C/129 Md. Atiul Ansary and I left STF, WB (HQ), Kolkata Office at about 17:45 hrs along with laptop, portable printer, power back up, narcotic kit, investigation kit, weighing machine and other necessary articles for collecting information about illegal narcotic dealings in Jalpaiguri, Siliguri and adjacent areas. On 30/11/22 morning we arrived at STF Office Siliguri Unit and stayed there. On 30/11/22 and 01/12/2022 We left our Siliguri Unit office for Siliguri and Jalpaiguri area to collect intelligence regarding narcotic dealings and then back to STF Office Siliguri Unit. Today on 02/12/2022 at 14:50 hrs I received a secret information from my source that one person will be coming at Fulbari Ghoshpukur Bypass road under NJP PS, Dist. Jalpaiguri in between 15:30 hrs and 16:30 hrs with huge quantity of contraband article i.e Heroin. As per this information was noted in STF WB Siliguri Unit GDE No. 143 dt 02/12/2022 & also informed the matter to Insp. Sankar Chowdhury, O/C Narcotic, STF WB who brought the information to the notice of superior authority of STF, WB accordingly and he informed me that Addl. SP Siliguri Unit, WB STF will give necessary order to work out this information. After obtaining necessary order from the superiors a raid team has been formed including ASI Jahangir Alam, C/142 Ratan Bhunia, C/128 Golam Muftafa, C/129 Md. Atiul Ansary and I. Today on 02/12/2022 at 15:20 hrs I along with ASI Jahangir Alam, C/142 Ratan Bhunia, C/128 Golam Muftafa, C/129 Md. Atiul Ansary left STF Office Siliguri Unit for Fulbari Ghoshpukur Bypass road under NJP PS, Dist. Jalpaiguri along with laptop, portable printer, UPS, narcotic field testing kit, investigation kit box, electronic weighing machine and other necessary articles to work out the information vide WB STF Office Siliguri Unit GDE No. 144 Dt. 02/12/2022.
