

SUB: COMPLAIN REG APPREHENSION OF 2 PASSENGERS SUSPECTED TO BE BANGLADESHI HOLDING FRAUDELANTELY OBTAINED INDIAN IDENTITY DOCUMENTS.

Sir,

On 05 Dec 2022 (at 0930 Hrs), the following passengers intended to travel to Bangkok (Thailand) from Bagdogra by Druk Airways flight No KB-130 approached for their departure immigration clearance.

2. While interacting with the passengers, it is revealed that both are not Indian nationals and had obtained Indian documents fraudulently.
3. Based on that, they were questioned thoroughly and later they had accepted the fact that they are Bangladeshi by birth and crossed over to India and got Indian documents.
4. Copy of the statement accepting the facts that they are Bangladeshi national along with seizure list is also enclosed herewith.
5. The above mentioned passengers are hereby handed over to you for further necessary action.
