I, Smt. Manjula Nag (Dey), W/O Sri Buddhadeb Dey@Sanju, D/O Sri Gokul Chandra Nag, now resident of C/o Sri Gokul Chandra Nag, C/O Kanchanjunga Industries Grill workers, D.B.C.Road, Deshbandhupara, P.O. Siliguri, Dist. Darjeeling, do hereby lodge this FIR to the effect that on 21/11/2021, at Siliguri, I was married to Sri Buddhadeb Dey@ Sanju, S/O Sri Muktipada Dey, resident of Shivalaya Villa, Flat No.1C,1" floor, 61 North station Road, P.O. Agarpara, P.S. Khardah, Dist North 24 parganas, near United Bank of India, Kolkata -700109, who works as property advisor under Somany realtors Pvt. Ltd., Real estate agency in Kolkata, 2nd Floor, 40, Ashutosh Mukherjee Road, near Netaji Bhawan, Bhowanipore, Kolkata, west Bengal-700020. And my family fulfilled all their dowry demands.

After marriage, I started living with my husband mother in law, father in law in my matrimonial house at Shivalaya Villa, Flat No.1C,1" (foor, 61 North station Road, P.O. Agarpara, P.S.

Khardah, Dist North 24 parganas, near United Bank of India, Kolkata -700109.

Since the day of my reception, my husband started misbehaving with me and within a few days I realized that he was not interested to persue a happy married life with me. He liked to spend time with his friends and used to go out early and come home very late and night and very often he used to come home drunk and quarreled with me and on other days he would stay out at night on various pretexts.

If I asked any question or protested about his abnormal timings, he and his parents used to insult

me and use abusive words.

My husband earned around Rs.50,000.00(Rupees Fifty Thousand only) every month but he did not spend a farthing for me. Even if I was sick I would not be treated by any doctor by them. My husband increased his torture day by day and one day when I could not tolerate any further and cried he told me to commit suicide.

I used to do all household work but they made my married life intolerable. In January when I became very sick they did not take me to the doctor and made me do all the house hold work. After about two months of marriage my husband clearly told me that he hated me and told me to stay away from him and not to touch him. After this his tantrums increased and he used to beat me up on trivial issues after coming from office at night. They stopped giving me proper food and

I became very weak physically.

On 3rd February 2022 my husband asked me to give him a rope to hang himself and being shocked when I asked him what happened he told me to give him a divorce as he could not tolerate my presence in his room or house. After two days he told me that he wanted to marry his girlfriend but when I asked him and his family why my life was destroyed when he wanted to marry his girlfriend they shouted and screamed on me and told me to get out of the house. However I was so shaken that I could barely think and kept on compromising with their cruel behavior.

On 21" March he came from office and picked up a quarrel and told me to get out of his house but I again kept quiet and tried to compromise with him.

In April my inlaws called my family to discuss the problem but when my family members came on 10/4/2022 my parents in law, husband and sister in law's husband started abusing and insulting me in front of them and told them a lot of lies regarding my day to day behavior and when my family tried to say a few things for me, my in laws started blaming them for everything and shouted at them and abused them and insulted them mercilessly. However my family members went back without telling them anything and wanted me to adjust somehow.

Thereafter my husband used to taunt me ask how long I would stay in their house and even threatened to kill me if I did not leave their house. He came home drunk and abused me and if I

said anything he and his parents would tell me to leave their house immediately.

I asked my father to come again and take me home for some days till my husband's anger cools down and my father decided to come and take me on 16/5/2022 but on 13/5/2022 my husband picked up a quarrel with me and told me to go out of the house in most abusive language on the instigation of my mother in law and even he best me and caught my neck and threw me on the bed roughly and thereafter he tried to throw me out of the house but I prayed to be allowed to stay till 16th and thereafter he left the house and did not come home at night.

On 15/5/2022, I had to be taken to the hospital by my father as I had severe injuries on my body and I was suffering from severe pain but my husband told me not to come back again. I could not bring any of my stridhan properties with me or the gifts given to me in marriage as I was not even

able to walk by myself due to the injuries.

After this my family tried to reconcile the matter in several ways and even called my busband and his family members on mobile to reconcile the matter but my husband renounced the marriage and asked for a mutual divorce. As such no further mediation was possible under the circumstances. My husband and in laws have kept my stridhan with them and I fear that they may misappropriate the same. During this short span of my married life ,I have suffered a lot because of the continuous physical and mental torture by my husband and inlaws.

It may be mentioned here that I could not lodge the FIR earlier because I was in a state of shock and recovering from my injuries and my family was trying for mediation through different sources. But recently on 2/11/2022 and again on 10/11/2022 some unknown anti-social person came to my father's house where I am residing now and threatened us with dire consequences if I

do not give divorce.

Since my husband has acquaintance with many criminals I am scared for my own as well as my

family's safety and have come to you for help urgently.

Sir, the aforesaid activities of my husband, his parents, sister and her husband have gone beyond my tolerance. I have lost all my hopes to resume my matrimonial life any further and I am certain that I will be killed if I return to my matrimonial home. I am now in a helpless condition and I need your help urgently to start appropriate legal action against my husband Sri Buddhadeb Dey, my father in law Sri Muktipada Dey, my mother in law Smt. Sima Dey, all residents of Shivalaya Villa, Flat No.1C,1" floor, 61 North station Road, P.O. Agarpara, P.S. Khardah, Dist North 24 parganas, near United Bank of India, Kolkata -700109 and sister in law Manashi (Dey) Singh and husband Sri Apurba Singh, C/O Star institute computer Centre, Pinkal more, Garulia, Shyam nagar, Dist. North 24 parganas.
