- I, PSI Chiranjit Saha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint to the effect that today on 07.12.2022 at 14.25 hrs while performing night patrolling duty, received a source information that one person namely Ajay Chauhan (23 years) S/O- Lt Krishna Chauhan of Prakashnagar, W-43, PS-Bhaktinagar, Dist- Jalpaiguri is selling liquor at Prakashnagar under Bhaktinagar PS without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- C/986 Rajib Sarkar, CVF /-935 Biplab Roy, CVF/619 Dharmendra Roy had been to the said place to verify the veracity of the information. On reaching there and as identified by the source it found that one person Ajay Chauhan was selling and storing liquor at his house situated at Prakashnagar under Bhaktinagar PS. Subsequently, I along with my force cordoned the place and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted place seized articles were found at that place. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03(three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 15.25 hrs to 15.45 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.
- I, therefore pray before your good self that a specific case may kindly be initiated against Ajay Chauhan (23 years) S/O- Lt Krishna Chauhan of Prakashnagar, W/N-43, PS-Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
