In producing here with the one arrested accused person namely Jaynath Ray-41yrs s/o Raghunandan Ray of Haiderpara Bazar near Buddhabharati School, Ward No-39, P.S Bhaktinagar, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

25 (Twenty Five) pet Bottles of Himalayan Gold 60 up Country Spirit each bottle containing 600 ML which was kept in one big nylon bag.

I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 18.12.22 at about 20.10 hrs received a source information that the above noted accused person has possessed huge amount of liquor in his house at Haiderpara, Near Buddhabharati school, under Bhaktinagar PS for selling the same to local customers. This refers to Bhaktinagar PS GDE No. 1428 Date. 18.12.22. Accordingly the information shared I/C Bhaktinagar PS and as per your kind direction I along with ASI Dipak Karmakar, C/ 1431 Dilip Barman, CVF/614 Sumit Kr. Roy, CVF/935 Bipllab Roy, CVF/619 Dharmendra Roy of Bhaktinagar PS left PS to work out the information. At about 20.30 hrs we reached at Haiderpara and as shown and being identified by the source held raid at the aforesaid house and apprehend one person who disclosed his name and address as noted above. Further maintaining his decency and observing all formalities searched inside the house and recovered huge amount of above noted seized liquor. On demand of license and documents in respect of possessing the liquor he failed to produce the same. On enquiry the apprehended accused person admitted his guilt and confessed that he has possessed above noted liquor for the purpose of selling to his designed customers for his wrongful gain. He also stated that he has been doing this act illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 20.45hrs to 21.15 hrs as he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Jaynath Ray-41yrs s/o Raghunandan Ray of Haiderpara Bazar near Buddhabharati School, Ward No-39, P.S Bhaktinagar, Dist. Jalpaiguri under proper section of law and arrange for its investigation.
