With due respect and humble submission I, Sagar Prasad Son of Pradip Prasad would like to inform you that yesterday around 1.30 pm when my father Pradip Prasad and Ranjit Kumar Prasad were present in Siliguri Regulated Market in their Shop to sell oranges as in Regulated Market everyone sells their products like fruits and vegetables in floor to display at that time one person named Rahul Thapa came in a vehicle Mahindra Bolero and asked for the rates when we said that we are wholesaler and don't sell our products in retail price if they are interested in wholesale purchase then we are ready to bargain hearing that he intentionally crushed more than 200-400 fresh oranges and was fleeing when one of my laborer intercepted him and made him stop. At that time when my father Pradip Prasad and uncle Ranjit Kumar Prasad asked them the damage said Rahul Thapa started assaulting my uncle, father and the laborers and was in intoxicated and when my father tried to stop him said Lilawati Thapa and Smita Giri was stealing two three bags of oranges and loading in their car.
