## Sub: F.I.R.

Respected Sir,

With due respect I, Varun Lakhotia, S/o Raj Kumar Lakhotia, resident of "Astha Apartment", Naya Busty, Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, would like to draw your kind attention to the following facts:-

- 1. My mother is Smt. Sumitra Lakhotia, wife of Sri Rajkumar Lakhotia.
- 2. That my elder brother namely Manish Lakhotia got married with one Monika Lakhotia in the year 2004. Immediately after marriage they got separated from my parents and started living together in Jaigaon as my brother had settled in Jaigaon for his business.
- 3. That in the year 2020 both my brother and his wife were residing in a rental flat at Jyoti Nagar, Siliguri and lastly they together resided at the said rental flat at Jyoti Nagar.
- 4. That due to some disputes between my brother and his wife, Monika Lakhotia requested my mother and father to allow her in their flat for a week in the month of January, 2021.
- 5. That my mother allowed her out of courtesy for seven days in her flat with a hope that she would leave the flat after staying one week. Even after elapse of one week she further told my

mother that she needed some more time. My mother could not say anything as she is the wife of her son. In the meantime she cleverly shifted her belongings from the rental premises to our flat.

- 6. That thereafter my brother has already hired a flat at Church Road. Today my brother has taken all her belongings to his rental premises so that they together being husband and wife would lead their conjugal life at such flat.
- 7. That after a while at about 3pm today, my sister in law (Monika Lakhotia) along with some people namely Sandeep Karnani S/o Banwari lal Karnini R/o Somani Mill Compound Siliguri, Manish Malpani, S/o Sushila Devi Malpani, R/o Malpani Katra, Rail Gate No 1, Slliguri -05, Ashok Mundhra, S/o Om Prakash Mundhra, R/o C/o RA Communcation, Mahabirshtan – 04; Rajesh Agarwal (Ph No - 9434020016) having his office at Opp. Arogya Niketan, Khalpara, Banwari Lal Karnani R/o Somani Mill Compound Siliguri, and other 10 to 15 people surprisingly came to our flat. The main entrance of the flat was closed from inside. They first of all broke the latch of the Iron Gate and thereafter they hit the wooden gate with hammer and broke the lock of the wooden gate. They entered into the flat with force. When my mother was trying to resist them, Namely Sandeep Karnani, Rajesh Agarwal, Banwarilal Karnani, Manish Malapani, Ashok Mundhra and others, they assaulted her and my younger sister in law namely Pooja Lakhotia. They touched her body as a result her modesty was outraged. They used some slang languages and abused her. The wife of my elder brother Monika Lakhotia was entered forcefully by the above mentioned Sandeep Karnani, Rajesh Agarwal, Banwari lal Karnani, Manish Malapani, Ashok Mundhra and other people who were present there. After sometimes they left the flat but at the time of leaving

some valuable articles such as my mother's gold chain, wrist watch and a show piece item were taken by them.

8. That Monika Lakhotia, with the support of Adv Rajesh Agarwal who is also a land and property dealer, with the intention of taking over the property from my mother has forcefully entered my mother's premises and threatening my mother and father with dire consequences and false cases.

Therefore I request you to investigate into the matter and to take necessary steps against them and thereby I shall be highly obliged to you.
