Sir,

With benign submission I, SI. Sumit Rawat now attached to Siliguri PS. SPC do here by lodged this written complaint against the accused driver namely Subal Das S/O. Joydeb Das of Matigara Rana Nagar PS Matigara Dist. Darjeeling of the truck Reg No. WB/23/1017 and one other named Biswajit Roy S/O. Jyotish Roy of Matigara Parimal Nagar PS. Matigara Dist. Darjeeling boarded in the said truck and after producing him along with one Truck bearing Reg No. WB/23/1017 loaded with Sand and River Bed materials with its documents as per seizure list to the effect that on 23.12.22 at about 23.25 hrs in course of performing Special Naka duty at Airview More under Siliguri PS Vide Siliguri PS Special CC No. 2203 Date. 23.12.2022 received an information that one truck having Reg. No. WB/23/1017 coming towards the Naka point at Airview More from Pradhan Nagar PS Side through Mahananda Bridge loaded with sand and River Bed Materials beyond it's scheduled measurement and quantity as per challan.

On being signaled in front of Air View More the driver of the vehicle stopped his vehicle and found the owner of the vehicle boarded on the vehicle too. On demand the driver produced the documentary papers relating to the vehicle and a photocopy of challan against the loaded sand and River bed materials. On perusal of the photocopy of papers it could be learnt that one E-Challan No. 4961365/S/22-23/231220224854/PS, of 150 CFT sand and river bed materials which can be carried by the said truck, issuing from Mining Lease Holder named Goutam Dey and it also appears that the owner of the vehicle Reg. No. WB/23/1017 is Jyotish Roy S/O. D. Roy of Parimal nagar, PS. Matigara Dist. Darjeeling

On physical verification it could be found that the truck was loaded with sand and river bed materials. Thereafter the driver of the truck and owner could not produce the original weigh slip or challan against his loaded truck and the said truck is carrying approx 220 CFT which reflects that the said truck carrying approx 70 CFT excessive Sand/RBM than the permitted quantity as per the photocopy of challan which clearly indicates that the said truck carrying stolen sand and river bed materials and carrying the same to deliver to their designated customers for their wrongful gain.


Under the circumstances the above driver along with one other boarded in the said truck and others received dishonestly stolen property knowing it to be stolen property for disposal of the same from the place noted in the challan. On further interrogation the accused driver could not produce any valid documents in support of his exclusive possession of the said sand and river bed materials loaded in the truck. The sand which falls under is mines and minerals substance.

Accordingly, I seized the said truck and its available documents and photocopy of challan in presence of witness as well as accused driver and owner of the truck Reg No. WB/23/1017 duly signed by them and arrested the accused driver and owner complying all the direction of the Hon'ble Apex Court of India in order to arrest.


Therefore I, pray before you that a specific case may kindly be started against accused driver truck Reg. No. WB/23/1017 namely Subal Das S/O. Joydeb Das of Matigara Rana Nagar PS. Matigara Dist. Darjeeling and one other named Biswajit Roy S/O. Jyotish Roy of Matigara Paribahan Nagar PS. Matigara Dist. Darjeeling and owner of the truck Reg No. WB/23/1017 under suitable sections of law and to arrange for its investigation.
