With due respect, I am producing herewith 02 (Two) arrested accused persons namely (i) Raj Kumar Sahani (38) s/o Achak Sahani of Rajaholi, PS-New Jalpaiguri, Dist.- Jalpaiguri (ii) Jalandar Sahani (23) s/o Bhuneswar Sahani of Rajendra Nagar, Kuli Para, Ward No.- 01, PS- Pradhan Nagar, Dist.- Darjeeing, under arrest. The ground of arrest duly been communicated with him and the following articles under seizure:-

- (i) 01 (One) 7.65 MM auto Pistol USA (One shooter) measuring 20 cm in length Approx including its 15 CM barrel with one trigger, striking hammer, striking pin in working condition and a magazine loaded with one 7.65 mm Live ammunition Marked as "Exhibit-"A".
- (ii) One 7.65 mm loaded arms in Exhibit-"A" marked as Exhibit-"B"
- (iii) U2 (Two) round of 7.65 mm live ammunition marked as Exhibit-"C" found from the possession of Jalandar Sahani (23) s/o Bhuneswar Sahani of Rajendra nagar, Kuli Para, Ward No.- 01, PS-Pradhan Nagar, Dist.- Darjeeing
- (iv) 01 (One) Vivo Smart Phone having IMEI No.- 866043054388833 & (ii) 866043054388825.
- (v) 01 (One) Blue Color Red Me Smart Phone having IMEi No.- 860041053306000 & (ii)

I. SI Pradeep Diyali of NJP PS, SPC do hereby lodge this written complaint against the above noted 02 (Two) arrested accused persons. In this regard, I beg to report that today i.e. on 26.12.2022 at 1805 hrs 1 received a secret information that two persons came to Canal Road, near Delhi Public School, under PS- NJP, Dist.- Jalpaiguri with improvised fire arms and ammunition most probably for committing heinous crime. Accordingly, I diarised the information in General diary vide NJP PS GDE No-1200 dated 26.12.2022 and informed the fact to you. As per kind order and direction myself along with VP/13 Januarul Islam, VP/08 Laxman Roy, HG/794 Ranjit Roy and CV/306 Bisawajit Roy, CV/824 Niru Kumar Yaday and CV/116 Robit Kumar Mahato all of NJP PS, SPC Teft Canal Road, near Delhi Public School, under PS-New Jalpaiguri PS, Dist.- Darjeeling with investigation kit—to work out the information in hand by Govt. vehicle. We reached at the spot i.e. Canal Road, near Delhi Public School, at about 1835 hrs and as indicated by the source we able to apprehend two persons. On being asked they disclosed their identity as noted above. As per source information, that they possessesed improvised fire arms and ammunition Hence, immediately I searched the above noted detained persons and found (i) 01 (One) 7.65 MM auto Pistol USA (One shooter) measuring 20 cm in length Approx makeling it; 13 CM barrel with one trigger, striking hammer, striking pin in working condition and a Bragazine and loaded with one 7.65 mm Live ammunition Marked as "Exhibit-"A" found from the possession of Raj Kumar Sahani (38) s/o Achak Sahani of Rajaholi, PS-New Jalpaiguri, Dist.- Jalpaiguri concealed in his wriest (n) 02 (Two) round of 7,65 mm live ammunition marked as Exhibit-"B" found from the possession of Jalandar Sahani (23) s/o Bhuneswar Sahani of Rajendra Nagar, Kuli Para, Ward No.- 01, PS- Pradhan Nagar, Dist - Darjeeing kept in right side of the jeans pocket (iii) 01 (One) Vivo Smart Phone having [MF] Nac: 306043051 258833 & (ii) 866043051388825 (iii) 01 (One) Blue Color Red Me Smart Phone having IMfa %a stability and mprovised fire arm and

infinition illegally, On demand they failed to produce any document in support the said vised fire arm and live ammunition which has been found from their possession. Thus when involvement in carrying and possessing illegal fire arm and live ammunition was established, I ed that's up wised loded fire arms and 03 (Three) rounds of live animumition and two smart Phoen under proper seizure list duly signed by them as well as by available witnesses. The whole processes of seizure and febelled was made in between 1905 hrs to 1945 hrs on 26.12.2622. Accordingly, Larrested both the apprehended accused persons after issuing memo of arrest informing them about the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused persons namely (i) Raj Kumar Sahani (38) s/o Achak Sahani of Rajaholi, PS-New Jalpanguri, Dist. Jalpanguri (ii) Jalandar Sahani (23) s/o Bhuneswar Sahani of Rajendra Nagar. Kuli Para, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeing are desperate and dangerous in nature as they were carrying the said fire arm and ammunition with an objective to commit hemous crime in the locality.

As they have willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely (i) Raj Kumar Sahani (38) s/o Achak Sahani of Regalion, PS New Jalpaiguri, Dist. Jalpaiguri (ii) Jalandar Sahani (23) s/o Bhuneswar Sahani of Rajendra Nagar, Kuli Para, Ward No.- 01, PS-Pradhan Nagar, Dist.- Darjeeing under appropriate section of law and arrange for its investigtion.
