That after my marriage my husband took me in my matrimonial home at the address mentioned above and since then we are living there as husband and wife. That in the said marriage my mother did everything without requiring my husband to spend anything on any account and even though my mother has to provide gifts and presents to my husband. That since the inception of marriage my husband treated me like maid as such I used to do the household work throughout the day but even after so much effort from my end to keep our matrimonial life peaceful my husband were dissatisfied with me and he always abuse me in filthy languages. That during the course of our marriage I gave birth to one male child namely Nilesh Rizal in the year of 2019 and one female child namely Nishita Rizal in the year of 2021. That after the birth of my female child the physical torture of my husband has increased manifold and he on every night after intoxicated state started to beat me with fist and blows using filthy languages. That if my mother-in-law come to rescue me in the hands of my husband he also beat his mother with fist and blows and also threatened us that he will kill both of us including my minor children. That on 22.12.2022 at about 11 p.m my husband came at home after drinking alcohol and started to beat me seeing this when my mother-in-law came to rescue me he also beat her and also forcibly took the ATM, Bank's passbook of my
