I, Sri Suman Sarkar , S/O- Late Sunil Kumar sarkar Assistant Engineer & Station Manager ,WBSEDCL, Siliguri Town CCC under P.S. Siliguri empowered by the Electricity Act 2003 (Amendment Act 2007) do hereby lodged this complaint against Subrata Chandra (present user) for committing unauthorized use of electric connection U/S 135 1(a) of the Electricity Act read with Amendment Act 2007 as stated here under.

On 30.12.2022 at about 04.05 PM , Sri Suman sarkar alongwith Sri A. Mahandeo ,D.E. (S & LP) Pranab Sikhder SO (S & LP) ,Rajesh Kumar singh ,Sr. T.S.H. Siliguri Town CCC Conducted one surprise checking premises at Sri Sunil Kr. Raha (present user Subrata Chandra), H/NO.199,W/NO.5 Siliguri,Darjeeling .

During inspection offence U/S 135 1(a) of the Electricity Act was detected. The accused person at Sri Sunil Kr. Raha (present user Subrata Chandra), H/NO.199,bidhan Road,W/NO.5 Siliguri,Darjeeling was using electric power by meter bypassing in the deemed premises by using service cable illegally. Details process of theft is enclosed with INSPECTION report.

As theft of Electricity was detected during inspection in our presence and representative of subrata chandra (i.e. Sukumar Ray), Inspection team requested to Sukumar Ray who has been presence of the place of occurrence to become seizure witness . So I seized the above meter in presenting seizure list in presence Sri A. Mahandeo ,D.E. (S & LP) Pranab Sikhder SO (S & LP) ,Rajesh Kumar singh ,Sr. T.S.H.
