Dear Sir,

I, Kabir Chhetri, residents of Green Park, Tea Auction Road, Police Station- Pradhan Nagar, Siliguri, District Darjeeling, and beg to lodge this complaint as under:-

1. I employed at Gupta Hotel and Restaurant situated at Mallaguri, Siliguri and are residents of the address as aforementioned.
2. Last Night at about 11.30 pm, while we were returning to our company accomodation, we saw few infamous "gundas" of our locality namely, (i) Rahul Das, son of Laxmi Das, (ii) Mohd. Baktiar, son of not known (ii) Mohd. Sonu, son of Mohd. Kesar and all residents of Green Park, Tea Auction Road, Siliguri, Police Station- Pradhan Nagar, District- Darjeeling, standing near kiran moti apartment.
3. Fearing any confrontation with the said persons which may lead to any untoward incident, we decided to silently pass by them and quickly reach our homes.
4. However, as we approached near them, the said person Rahul Das, to our utter shock and despair suddenly started abusing us in filthy languages, to which we did not respond fearing harm to ourselves and as we were passing by them, they, without any threat or provocation, whatsoever from us, after sometime the above mentioned MD sonu and MD Baktiar suddenly started beating us in a completely intoxicated state, with fists and blows and as we were trying to resist their said attacks and somehow escape from there, they took out some sharp objects and also started attacking us with the pointed metal end of the keys with clear intent to kill us, due to which we sustained heavy injuries on our bodies as one of us, namely Kabir Chhetri got a deep cut near his ear and the other, sustained deep wounds on his skull at three places.
5. I somehow managed to make hue and cry and fortunately our employer Mr. Sunny Gupta was incidentally passing by the place of incident and seeing us in the said condition

he immediately came to our rescue and seeing him the said persons Mohd. Baktiar, Mohd. Sonu and Rahul Das managed to escape from there after pushing and shoving him aside.

6. We were immediately rushed to the hospital by Sunny Gupta and upon receiving treatment from Civil Hospital, we are lodging this complaint after a slight delay as we have been recuperating from the shock and pain from last night's incident as narrated above.

You are therefore, requested to take necessary action against the aforesaid persons, namely (i) Mohd. Baktiar, son of not known (ii) Mohd. Sonu, son of Mohd. Kesar and (iii) Rahul Das, son of Laxmi Das, all residents of Green Park, Tea Auction Road, Siliguri, Police Station- Pradhan Nagar, District- Darjeeling and bring them to justice.


