Dear Sir,

- 1. This is to inform you that we have total 6.25 acres of land at Dagapur, PO & PS Pradhan Nagar, Siliguri 734003 which is situated opposite to Hyundai Showroom, Dagapur, PO & PS Pradhan Nagar, Siliguri since last 40 years under khatian no. 32/1,32/2,79/1,40/1, Mouza Daknikata, Paragana Pthatghata, Block Matigara, Siliguri (Xerox Copy Enclosed). We have not sold a single katha of land to anybody since purchase till date against above land under above khatian numbers and various numbers of deeds.
- 2. That there is a nursing home named Greenage Hospitals PVT LTD standing on our land at Mouza Daknikata, Dagapur (Opposite to Hyundai Showroom) NH-55, PO & PS Pradhan Nagar, Siliguri, District Darjeeling.
- 3. That it is found that there were 6(Six) numbers of labour quarters and storage rooms where valuable goods was stored and the boundary wall situated on the back side of our said nursing home have been demolished by the representative of Hemendra Smriti Healthcare PVT LTD and by Shri Rajesh Rajak, Shri Rajib Rajak, Smt. Sarita Rajak, Shri laldeb Rai WITHOUT ANY VALID COURT ORDER with a malifide intention to cause damage to our said property and also to encroach upon the same land on the basis of forged documents.
- 4. That on enquiry we have come to know that representative of Dr. Abhishek Biswas, Director of Hemendra Healthcare PVT LTD. His partner Anup De, Sri Rajesh Rajak, his wife Sarita Rajak and his brother Rajib Rajak of Kadamtala, Champasari North Mallaguri, Ward No.46, PO & PS Pradhan Nagar, Siliguri and Shri Laldeb Rai along with their other associates trespassed into our said land and demolished the said labour quarters, storage rooms and the

- 5. Yesterday i.e. on 28/1/2022 our security person noted that some miscreants (8-10) numbers deputed by Hemendra Smriti Healthcare PVT LTD, Sri Rajesh Rajak, his wife Sarita Rajak and his brother Rajib Rajak of Kadamtala, Champasari North Mallaguri, Ward No.46, PO & PS Pradhan Nagar, Siliguri and Shri Laldeb Rai (Xerox Copy Enclosed) broke the lock of our gate behind our Nursing Home and fixed up their lock for unauthorized occupation of the said land on the basis of forged documents WITHOUT ANY VALID COURT ORDER.
- 6. In this connection it is to be noted that we have filed several Title Suits against various persons who are trying to occupy our land forcibly on the basis of forged documents to the Junior Division Civil Judge, Siliguri. Out of these several title suits we are mentioning here one of the title suit no. 254/2022 dated 29/11/2022 against Hemendra Healthcare PVT LTD which is pending before the court of Junior Division Civil Judge, Siliguri.
- 7. It is also to be noted that we have filed an appeal to the DLLRO Darjeeling in the above matter for more than 3 months before against which hearing date have not been fixed up by the DLLRO Darjeeling and the decision is still pending.

Under the above circumstances you are requested to LODGE and FIR against the following persons details of which are given below to protect our land from these miscreants/criminals in terms of law till the decision comes from DLLRO, Darjeeling and Junior Division Civil Judge, Siliguri.
