Respected Sir

I Smt. Bhaswati Das, wife of Sandip Basak, resident of 104 Krishna Neer, Ward 21, Rabindra Nagar, beg to state that my husband due to his service is presently out of station and posted at Hyderabad. Taking advantage of this fact my sister in law viz Jayeeta Basak, (resident of 44 Hemanta Mukherjee Sarani, Rabindra Sarani, 734006) and her husband Kaushik Paul from the 1<sup>st</sup> week of this month have been torturing me mentally and physically and threatening me to vacate my matrimonial house immediately, otherwise they will throw me and my minor child from the house forcefully. On 28<sup>th</sup> December, all of a sudden my sister in law Jayeeta Paul and her husband Kaushik Paul entered into the portion where presently I am living at my matrimonial house and by using physical force, Jayeeta Paul and Kaushik Paul tried to oust me from my matrimonial house. I then shouted fearing for my life and my son's, and thereafter they left from the house but at the time of leaving my house they threatened me with dire consequences. Immediately I informed everything to my husband who is at presently residing at Hyderabad. My husband assured me that as soon as possible he will return to Siliguri and thereafter we will proceed against Jayeeta Paul and Kaushik Paul as per the provision of law. Thereafter yesterday at about 8 PM when I was feeding my minor child, suddenly said Kaushik Paul without my permission broke into my room, pushed my maid, pulled my hand and started touching me with evil intention. He was also constantly abusing me in unmentionable language and threatening me to leave the house immediately. Facing such physical force I started shouting and hearing my voice some local people rushed to the spot and thereafter said Kaushik Paul fled away from my matrimonial residence, but not before forcefully taking away the gold chain that I was wearing.

Sir, being a helpless lady and having no security I am very much scared for my life and also about the safety of my minor child. I therefore request you to take drastic legal action against said Kaushik Paul and Jayeeta Paul in accordance with law and your good office is very much expected in this regard.
