I Dilruba Khatun w/o MD. Israel belongs to Halal, PO-Chowpatwaria, Dist- Darjeeling, P.S- Bagdogra want to inform you that today 01/01/2023 (Sunday) in evening at 7:00 pm MD. INTAJ & MD. NASIM passing by driving bike with full speed near about 90km/h to 100 km/h and he was full drunk alcohol and not in his consciousness and also he has not in his own control and He also don't know in what speed he is driving. So, I Dilruba Khatun sit at my grocery shop and in front of my shop there is a customer and huge crowd of customer. A lady customer was just a inch away from accident by INTAJ full speed bike. Then locals are shocked and stop MD INTAJ Bikes and locals just ask him to drive slow normally but in return MD. INTAJ used very dirty slang word to Dilruba Khatun and pushed her after that the locals came and pushed and shoved him (Shakka and Mukki) but not beat him they just pushed him in order to save Dilruba Khatun (Grocery shopkeeper) and solved the matter.

After that MD. INTAJ went home and came to fight with large number of people and drunkard man and they all try to broke the shop and beat MD. SAHRUK (Dilruba Khatun's son)

brutally and they also ~~other~~ attacked with bamboo(lathi) on the head of MD. SAHRUK and MD. INTAJ, MD. SERJIT &D. MANTAJ and MD. FIROZ along with group and the total group came to fight near about 500m away and their group who come to fight minimum 15 to 30 peoples along with MD. INTAJ, MD MANTAJ, MD. SERJIT and MD. FIROZ they all drunk and not in their control and consciousness MD. INTAJ and his brothers MD SERJIT and MD MANTAJ give MD SAHRUK life threat and they also told that as a (dhamki) that we will kill MD. SAHRUK and his brother MD IMAM in future and take our revenge. so, In future MD. INTAJ, MD. MANTAJ and MD. SERJIT may attack on MD SARUK and MD IMAM (sons of Dilraba khatun) in future and it may be convert into big dispute. so, I have humble request to you that please accept my application / file take necessary action as soon as possible
