

Sir,

I, SI Abhishek Theengh of Pradhan Nagar PS, SPC do hereby lodge this complaint to the effect that today on 05.01.2023 at about 00.30 hrs. I received specific source input that one vehicle has been coming from Samar Nagar side with huge amount of illicit liquor loaded inside one TATA Ace pick up van having Reg No. WB-73C-8737 for its disposal at Bihar clandestinely. Accordingly, I diarized the fact in Pradhan Nagar PS General Diary Book vide GDE NO- 217 Dated 05.01.2023 and consequently passed the information to you for your kind instruction. Subsequently, as per your direction myself along with ASI Ashit Singh, CV/992 Jagadish Biswas, CV/646 Baban Das and CV/242 Rakesh Mangar, all of Pradhan Nagar PS, SPC left Pradhan Nagar PS to verify the veracity of the information.

At 00.55 hrs. we reached at Samar Nagar Road under PS- Pradhan Nagar and started checking vehicles. After sometime being pointed by my source I found one white colored utility TATA Ace pick up van having number plate vide WB-73C-8737 was coming from Samar Nagar side. On sighting police team, the driver and handyman of the vehicle fled away from the spot taking the advantages of darkness to evade the police arrest and keeping the vehicle on road.

Then I searched the vehicle and recovered the following quantity of sealed foreign liquor bottles of different brands which was loaded in said vehicle:

(i) 444 (Four Hundred and Forty-Four) pieces sealed Royal Castle Blue premium whisky, each bottle containing 375 ml, MFD - 24.12.2022, blended and bottled by Mount Distilleries Limited, Mazitar, Rangpo, Sikkim, for sale in Sikkim only.

(ii) 100 (Hundred) pieces sealed Royal Castle Blue premium whisky, each bottle containing 750 ml, MFD - 24.12.2022 each blended and bottled by Mount Distilleries

Limited, Mazitar, Rangpo, Sikkim, for sale in Sikkim only.

(iii) 122 (One hundred and twenty-two) pieces sealed Russell Premium Whisky, each bottle containing 750 ml, MFD - 03/2020 blended and bottled by Mayell & Fraser Private Limited, Mazitar, Rangpo, Sikkim, for sale in Sikkim only.

The above noted articles could be found concealed in 28 (Twenty-Eight) pieces of plastic water pipes of different sizes loaded in the vehicle.

I also recovered and seized one number plate having Reg No. BR-11C-8737 kept under the driver seat. No supportive documents in respect of the vehicle, above noted goods and foreign liquor bottles could be found in the vehicle. Accordingly, I seized the above noted TATA Ace pick up van having number plate vide WB-73C-8737, Engine No. 278814103802, Chassis No. MAT445222AZC17797, one number plate having Reg No. BR-11C-8737, plastic pipes and sealed foreign liquor bottles from the spot. The whole process of seizure was made in between 01.25 hrs. to 03.45 hrs. in presence of available witnesses. There is every suspicion that the driver and handyman of said vehicle was carrying above foreign liquor bottles illegally after stealing from somewhere at Sikkim by using forged number plated vehicle and owner of the vehicle other may also be involved in this case.

Under the above circumstances, you are requested to kindly register a specific case under proper section of law against the driver, handyman, owner of the vehicle and others and arrange for its investigation.
