Sir,

I Maya Rai wife of late Ashit Rai, S/o late Buddhiman Rai resident of Auringley
locality, P.O Tung, P.S Kurseong, village Maharani Tea Garden, Kurseong District
Darjeeling West Bengal 734224 would like to make a complain before you and
respectfully submits :

1. That I am a legally wedded wife of Late Ashit Rai, having two childrens named
Abishek Rai of 23 years old and Ambika Rai of 20 years old.
2. That my husband passed away on 20.10.2021 at Desun hospital, Kawakhali
Siliguri.
3. That I require the death certificate of my husband for my daughter's education as
it is a very important document and also for other official purposes.
4. That for the said purpose I had approached the Matigara Gram Panchayat on
26.12.2022 as the document is very urgent for my daughter's education.
5. That from the said Gram Panchayat and the issuing authority I came to know that
one Laxmi Rai resident of Bodhi Apartment, near Sukna, P.S Sukna, P.O
Kurseong, District Darjeeling, issued death certificate of my husband on from
Gram Panchayat Matigara on dated 27.10.2021 by cheating, misrepresentation
, misleading, forgery and by fraudulent means which is utter surprise for me and my
daughter.
6. That in this death certificate I am represented as Late mother of Late Ashit Rai
, wherein the actual name of late Ashit Rai is Late Bina Rai.
7. That in the death certificate of Late Ashit Rai, it is mentioned that in the name of
the spouse of late Ashit Rai it is mentioned as one Laxmi Rai, wherein I am the
spouse and a legally wedded wife of Late Ashit Rai.

8. That this Laxmi Rai has misrepresented my name ,forged the document which is very vital part of my life which I have required for various official purpose and especially for my daughter .
9. That one Laxmi Sharma has misleded the authorized signatory ,disguising the Govt. Officer by obtaining the death certificate of my husband by means of forgery cheating, misappropriation criminal conspiracy and by means of false information document with malafide intention in taking away my rights, infact the said Laxmi Rai claims herself as a second wife of Late Ashit Rai.
10. That once the said Laxmi Rai had come to my home to throw me out and also my daughter who is physically challenged ,she threatened me several times, harassed me and my daughter just to displace me out of my house and to take away my rights.
11. That if this said Laxmi Rai keeps interfering and harassing our peaceful family life, my children's education ,my social and financial status ,and various others factors then I and my family will be severely deprived of our basic right.

That for this aforementioned reasons I pray before you and your good office to kindly investigate the matter as early as possible and do the needful.
