In producing herewith one arrested accused person namely Satish Roy (30yrs), S/o - Prasanna Roy of Madhab Danga, PO. + PS - Mainaguri, Dist - Jalpaiguri along with the following seized articles as per proper seizure list:

- 1. 07(Seven) sealed bottles of Kingfisher Strong Premium Beer each bottle containing 650 ML.
- 2. 10(Ten) sealed bottles of 60 up pet Galaxy Boss each bottle Containing 600 ML.
- 3. One Plastic Carry Bag.

I, ASI. Rabi Tamang of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 31.12.2022 at 16:05 hrs received a source information from Nawapara More, under Ambari-Falakata Out Post that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 1099, dated 31.12.2022. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) C/505 Tapash Dutta, (2)HG-1158 Niten Roy and (2) CV-01 Joychand Roy all of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Nawapara More area to work out the information. At 17:45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the local area, situated at Nawapara More and recovered the above noted articles from the possession of accused person namely Satish Roy (30yrs), S/o - Prasanna Roy of Madhab Danga, PO. + PS - Mainaguri, Dist - Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Abhijit Majumdar S/o. Lt. Ashim Majumdar of Ambari-Falakata, PO. Kamarvita, PS - NJP, Dist - Jalpaiguri and 2) CV-01 Joychand Roy of Ambari-Falakta Out Post, Under NJP PS/SPC after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 18:05hrs to 18:25 hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued him Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Satish Roy (30yrs), S/o – Prasanna Roy of Madhab Danga, PO. + PS – Mainaguri, Dist – Jalpaiguri under proper section of law.
