Ajit Sharma of Bidhan Pally near Sitala Mandir, PS- Dalkhola, Dist- Uttar Dinajpur (not verified) along with the following seized article under proper scizure as per seizure list; One transparent polythene containing total 382 grams of light brown colour powder suspected to be brown sugar and marked as "Exhibit- A" 20 (twenty) grams of light brown colour powder suspected to be brown sugar taken as (11)

sample from exhibit "A" for examination, kept in one zip look transparent polythene and marked as Exhibit "A-1"

One Yellow carry bag with the label 'CHAMAK' tea premium CTC tea, Mkt. by Sk Traders, (iii)

Daokhola, Mob. No- 8927972127 and marked as "Exhibit- B". One black colour backpack with the logo of a Bat which has two compartments and marked (iv)

One Samsung Mobile bearing IMEI No. 356890803320963/3593069493320962 and marked as Exhibit- "C". (V) as Exhibit-D'

I, SI Sailesh Subba of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person named Ajay Sharma (19), S/O- Lt. Ajit Sharma of Bidhan Pally near Sitala Mandir, PS- Dalkhola, Dist- Uttar Dinajpur (not verified) to the effect that today on 06. 01.2023 at about 16.55 hrs I received a specific source input that one person will be coming to Jaiswal Dhaba near Khaprail More under Matigara PS with huge quantity of Brown Sugar for delivering the same to his designated customers at the adjacent areas. The matter was diarized in General Diary vide Matigara PS GDE No. 281 Dt- 06.01.2023 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with ASI Tapan Das, C/810 Anjelus Minj, C/306 Wang Dorjee Lama, C/974 Mintu Sen, CV-155 Sukumar Das all of Matigara PS, \$PC left for Jaiswal Dhaba near Khaprail More under Matigara PS along with investigation kit by govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 282, Dated - 06.05.2023 and M.C.C No- 39/2023 Dated 06.05.2023. Considering the urgency and circumstances any search warrant or authorization could not be obtained as it would facilitate the offender for his safe passage.

On the way to Jaiswal Dhaba near Khaprail More, I requested one videographer namely Kamal Roy (25), S/O Chandi Roy of Matigara Khudirampally, PO+PS-Matigara, Dist.-Darjeeling and requested him to come at Jaiswal Dhaba near Khaprail More to accompany us as the entire process of search and seizure would have to be video-graphed. I also requested two independent witnesses namely (1) Avijit Sharma (39), 5/O- Nirmal Kumar Sharma of Matigara Rabindra Pally, PO+ PS Matigara, District Darjeeling and (2) Avijit Mitra (40), S/O- Ranjit Mitra, Matigara of Rabindra Pally, PO+ PS Matigara, District Darjeeling and make them aware of the information in hand and requested them to act as witness in case any search and seizure would be made to which they obliged. Thereafter we along with the independent witnesses reached at Jaiswal Dhaba near Khaprail More under Matigara PS. At about 17:45 hrs, reliable source pointed towards a person who was found sitting inside Jaiswal Dhaba and confirmed that he was the person that we were looking for. Seeing the Police party approaching towards him, the suspect tried to flee away from the spot but we managed to apprehend him. Thereafter, we disclosed our identity and the information in hand and stated him that he as well as his baggage will be searched in person for the purpose. At this, he after disclosing his identity as noted above admitted that he had in his possession some brown sugar for the purpose of selling the same to his designed customers as per their requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazette Officer. At this he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, he did not search the police party.

Accordingly, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Narendra Kalikotay, Assistant Commissioner of Police, SB, Siliguri Police Commissionerate, detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessing Brown Sugar at 18:35 hrs. and requested him to come at Jaiswal Dhaba near Khaprail More under Matigara PS to supervise the search and seizure.

rdingly at 19:15 hrs, Shri Narendra Kalikotay, Assistant Commissioner of Police, SB, Siliguri almissionerate arrived at the spot at Jaiswal Dhaba near Khaprail More under Matigara PS and as etc. In presence of two independent witnessee I searched the detained person observing all formalities described and recovered the above noted articles from the exclusive and conscious possession of the properson namely Alay Sharma (19), S/O- Lt. Ajit Sharma of Bidhan Pally near Sitala Mandir, PS-Bithola, Dist- Uttar Dinappur (not verified)

Further, as demanded by Shri Narendra Kalikotay, Assistant Commissioner of Police, SB, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC, the detained person namely Alay Sharma failed to produce any valid document in support of possessing of the brown sugar. Thereafter, I weighed the recovered packet with a weighing machine found 382 grams of brown sugar kept in the transparent pouch.

Accordingly, I seized the above noted articles from the exclusive and conscious possession of accused namely Ajay Sharma at the spot at Jaiswal Dhaba near Khaprall More under Magara PS under proper science list in presence of independent witnesses under the supervision of Shri Narendra Kalikotay, Assistant Commissioner of Police, SB, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining his signature and being acknowledged by the accused person and obtaining his aignature

Subsequently, I labelled and scaled the seized articles in presence of Shri Narendra Kalikotay, Assistant Commissioner of Police, SB, Siliguri Police Commissionerate and the independent witnesses and the accused person. The whole process of scizure was made in between 19:45hrs to 21 25 hrs.

Being further asked, the apprehend person namely Ajay Sharma admitted in presence of Shri Narendra Kalikote, Assistant Commissioner of Police, SB, Siliguri Police Commissionerate and other independent witnesses that they have procured the brown sugar clandestinely from Dalmohon Basak and Manu Basak, bot of Dalkhola, Uttar Dinajpur and Raju Mandai of Gazole Malda and for the purpose of selling the same in high rate to Dhemna of Pakistan Basti, Matigara and Tamanna of Goalapatti, Siliguri, He also disclosed that they have been dealing in this business of procuring and selling of brown sugar illegally for quite some time for his wrongful gain. I examined the above noted accused and also recorded his statement u/s 67 NDPS Act.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Ajay Sharma (19), S/O- Lt. Ajit Sharma of Bidhan Pally near Sitala Mandir, PS- Dalkhola, Dist- Uttar Dinajpur (not verified) is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Acti

Then, I arrested the above noted accused persons namely Ajay Sharma (19), \$/O- Lt. Ajit Sharma of Bidhan Pally near Sitala Mandir, PS- Daikhola, Dist- Uttar Dinajpur (not verified) after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely (1) Ajay Sharma (19), S/O- Lt. Ajit Sharma of Bidhan Pally near Sitala Mandir, PS- Dalkhola, Dist- Uttar Dinajpur (not verified), (2) Dalmohon Basak, (3) Manu Basak, both of Dalkhola, Uttar Dinajpur, (4) Raju Mandal of Gazole, Malda, (5) Dhemna of Pakistan Basti, Matigara and (6) Tamanna of Goalapatti, Siliguri and arrange for its investigation.
