- 6. That due to such abovementioned activities of my abovenamed uncles, I, alongwith my brother, widow mother and infant child is highly traumatized and finding it extremely difficult and alarming to reside at our abovementioned residence and also to enjoy and avail our right of our property.

Hence it is prayed before your good self to kindly look in to the abovementioned matter and take necessary actions against the said Ashoke Chakraborty and Pankaj @ Dipak Chakraborty, as per the due course of law for the ends of justice.
