I, Sikandar Iqbal Khan, 1/o. St. Suleman Khan, resident of Masjidpara, P.O. + P.S. Bagdogra Dist. Darjeeling would like to inform you that my wife Rukhsana Khatun while crossing the road near State Bank of India, Bagdogra T.A.F. Camp Branch at around 7:00 P.M., yesterday (i.e. 10/01/2023) was hit by a scooter and has been badly injured with fractures in the leg and hand and injury on the back side of the head. After the accident the scooter ran away from the spot. We picked up my ~~wife~~ wife and took her to Dr. Bhagat's Clinic and from there she is admitted at Mukta Nursing Home, Shivnandpur. I have become late in informing you since I was busy with the treatment of my wife.
