In this regard, I ASI Sanjay Basunia of Matigara P.S, SPC do hereby lodge this Complaint against above noted arrested accused person to the effect that on 13.01.2023 at about 14:05 hrs onwards I received a source Information that one vehicle one vehicle Truck bearing Reg. No. WB 73 E 0815 loaded with river bed materials (Stone) coming from Baswhbari Ghat side without any valid documents. Accordingly I inform the fact to Officer In charge, Matigara PS and as per his kind direction myself along with force had been to Bashbari Ghat under PS Matigara to work out the information in hand.
