he was walking towards the Said Hospital and when  
he reached near the Water Canal situated near  
Halal Busty under Bagdogra P.S then at that  
time one tractor coming from his side

Rammed into my father who was Aged About 56 years  
Suffered multiple injuries over his body and with the  
help of the local residents he was transferred and admitted  
to NBMC H Emergency department where the doctors  
declared him dead because of the serious injuries  
Suffered by Said Accident and As a Reason of Such  
inevitable loss I am lodging this complaint in your  
P.S with a view that proper Action is taken Against  
the owner / driver of the Said tractor.
