time one tractor coming from Kestopur side
rammed into my father who was Aged About 56 years

help of the local Residents he was transferred and admitted
to NBMCH Emergency department where the doctors
declared him dead because of the serious injuries
suffered by Said Accident and as a Reason of such
inevitable loss I am lodging this complaint in your

the owner / driver of the Said tractor.
