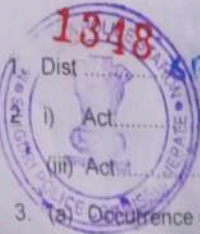

Sir,

With due respect, I am producing herewith 03 (three) arrested accused persons namely (i) Md Saddam Hossain (33 yrs) S/O Md Darajudin of Sutki Godwan, near Drifish Market, PS- Matigara, Dist.- Darjeeling (ii) Pradim Chhetri (24 yrs) S/O Subhash Chhetri of Sainik Puri, near Library, Khaprail, PS- Matigara, Dist.- Darjeeling (iii) Sangay Sherpa (23 yrs) S/O Late Passaang Sherpa of Daragaon, Sonada, PS- Jorebanglow, Dist.- Darjeeling the following articles under seizure :-

1. One iron made sharp cutting weapons called as Hasua and one torch light recovered from the possession of accused Md Saddam Hossain S/O Md Darajudin of Sutki Godwan, near Drifish Market, PS- Matigara, Dist.- Darjeeling.
2. One iron made sharp cutting weapon called as Vojali & one torch light recovered from the possession of accused Pradim Chhetri S/O Subhash Chhetri of Sainik Puri, near Library, Khaprail, PS- Mtigara, Dist.- Darjeeling.
3. One iron made sharp cutting weapon called as Vojali & one iron rod recovered from the possession of accused Sangay Sherpa Daragaon, Sonada, PS- Jorebanglow, Dist.- Darjeeling.

I, SI Shekhar Adhikary of Matigara PS, Siliguri Police Commissionerate beg to state that on 19.01.23 at 01.15 hrs received a reliable secret source information that that a gang of miscreants come at Chandmoni Bagan near Sky Dale under PS- Matigara, Dist.- Darjeeling with deadly weapons and assembled there and making preparation for committing dacoity at Pati Colony area under Matigara PS. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1029 dated 19.01.23 and informed the fact the Officer-In-Charge, Matigara PS, SPC. As per his kind order and direction myself along with C/1053 Pares Rava, C/219 Sanatan Chitrakar, C/374 Debraj Biswas, CV-155 Sukumar Das and CV- 387 Sukumar Barman all of Matigara PS, SPC left for Chandmoni Bagan under PS- Matigara, Dist.- Darjeeling to verify the veracity of said source input vide Matigara PS GDE No 890 dated 19.01.23. I also informed the fact to Night RT Van officer ASI Prabir roy and ASI Sanjoy Baasnia both of Matigara PS and directed them come to near Chandmoni Bagan to accompany with us. At 01.35 hrs we arrived at near Chandmoni Bagan under PS- Matigara, Dist.- Darjeeling. After a few time RT Van Officer ASI Sanjoy Basunia and ASI Prabir Roy along with force came to there and accompany with us. At about 01.50 hrs as indicated by the source we noticed that 08/09 persons assembled in a dark place at Chandmoni Bagan near Sky Dale and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 03 (three) of them with deadly weapons in their possession but 05/06 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they were assembled there for committing dacoity in a house at Pati Colony area. On search the above noted weapon of offence recovered from their possession. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested them under proper memo of arrest and observing all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made on 19.01.23 in between 02.35 hrs and 03.45 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons namely (i) Md Saddam Hossain (33 yrs) S/O Md Darajudin of Sutki Godwan, near Drifish Market, PS- Matigara, Dist.- Darjeeling (ii) Pradim Chhetri (24 yrs) S/O Subhash Chhetri of Sainik Puri, near Library, Khaprail, PS- Matigara, Dist.- Darjeeling (iii) Sangay Sherpa (23 yrs) S/O Late Passaang Sherpa of Daragaon, Sonada, PS- Jorebanglow, Dist.- Darjeeling and others 05/06 unknown persons and arrange for its investigation.
