- 1. That my marriage was solemnized with Bhaskar Roy, Son of Late Biplab Roy, resident of Maynapara, P.O. & P.S. Maynaguri, Dist- Jalpaiguri, on 10.03.2022 according to the Hindu rites and customs. At the time of marriage my father gave fold ornaments weighing 55 grams, expensive utensils, bed, almirah, sofa, dining table, etc. as per their demand.
- 2. That after marriage I started to live in my matrimonial house with my husband and mother in in-law namely Anjali Roy.
- 3.
