With due respect, I am producing herewith the arrested accused persons namely (i) Shiva Mandal (21) s/o Lt. Gobinda Mandal of Gorarbari, near Loknath Mandir, Bhola More, PS-New Jalpaiguri, Dist.- Jalpaiguri (ii) Hamenta Barman (27) s/o Lt. Sudin Barman of Bakravita, PS-New Jalpaiguri, Dist.- Jalpaiguri (iii) Muni Barman (18) s/o Lakhan Barman of Mamtapara, PS-NJP, Dist.- Jalpaiguri (iv) Abishek Mahato (21) s/o Rajendra mahato of Mamtapara, PS-NJP, Dist.-Jalpaiguri and the following articles under seizure:-

1. One Iron made Bhojali and one sharp cutting knife, One Torch Ligh, one Blunt Iron Road from the possession of accused namely Shiva Mandal (21) s/o Lt. Gobinda Mandal of Gorarbari, near Loknath Mandir, Bhola More, PS- New Jalpaiguri, Dist.-Jalpaiguri

One Iron made Hasua and one Iron made sabol from the possession of accused 11. Hamenta Barman (27) s/o Lt. Sudin Barman of Bakravita, PS- New Jalpaiguri, Dist.-

Jalpaiguri

One sharp cutting knife and one plastic made charger torch light and Iron Road from III. the possession of accused Muni Barman (18) s/o Lakhan Barman of Mamtapara, PS-NJP, Dist.- Jalpaiguri.

One Iron made Hasua, Screw Driver & One Blunt Iron Rod from the possession of Abishek IV.

Mahato (21) s/o Rajendra mahato of Mamtapara, PS-NJP, Dist.- Jalpaiguri.

I, SI Pradeep Diyali of NJP PS, Siliguri Police Commissionerate beg to state that on 18.01.2023 at 0045 hrs I received a secret source information that a gang of miscreants come to Thakuarnagar/South Shantinagar, with deadly weapons and assembled there and making preparation for committing dacoity at Madani Bazar, Thakurnagar, South Shantinagar, Baribhasa under New Jalpaiguri PS, Dist.- Jalpaiguri. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 772 dated 18.01.2023. As per kind order and direction of my superior officer myself along with ASI Khagen Barman, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy CV/824 Niru Kumar Yadav all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for Jabravita, South Shantinagar, PS-New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. I also informed the fact to night RT Van officer All Pradip Sarkar of New Jalpaiguri PS, Siliguri Police Commissionerate along with force and directed him to come to Jabravita, South Shantinagar to accompany with us. At about 0115 hrs on 18.01.2023 we arrived at Jabravita, PS-New Jalpaiguri PS, Siliguri Police Commissionerate. After a while ASI Pradip Sarkar along with force came to Jabravita and accompany with us. At about 0135 hrs we found that 10/11 persons assembled in a dark place at Jabravita, South Shantinagar, near Housing Comlex and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity at South Shantinagar, Baribhasa area.

On search of the apprehended accused persons I found (i) One iron made Bhojali and one sharp cutting knife, One Torch Ligh, one Blunt Iron Road from the possession of accused Shiva Mandal (21) s/o Lt. Gobinda Mandal of Gorarbari, near Loknath Mandir, Bhola More, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) One iron made Hasua and one iron made sabol from the possession of accused Hamenta Barman (27) s/o Lt. Sudin Barman of Bakravita, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) One sharp cutting knife and one plastic made charger torch light, One Iron Road from the possession of accused Muni Barman (18) s/o Lakhan Barman of Mamtapara, PS- NJP, Dist.- Jalpaiguri. (iv) One Iron made Hasua, Screw Driver & One Blunt Iron Rod from the possession of Abishek Mahato (21) s/o Rajendra mahato of Mamtapara, PS-NJP, Dist.- Jalpaiguri.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity at Soth Shantinagar and Baribhasa area, Madsani Bazar area, Thakurnagar area under New Jalpaiguri, Dist.- Jalpaiguri. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted four accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 0155 hrs to 0245 hrs.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Shiva Mandal (21) s/o Lt. Gobinda Mandal of Gorarbari, near Loknath Mandir, Bhola More, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Hamenta Barman (27) s/o Lt. Sudin Barman of Bakravita, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Muni Barman (18) s/o Lakhan Barman of Mamtapara, PS- NJP, Dist.- Jalpaiguri (iv) Abishek Mahato (21) s/o Rajendra mahato of Mamtapara, PS-NJP, Dist.- Jalpaiguri and arrange for its investigation.
