In producing herewith one accused person namely (1) Biswajit Roy (22), S/O- Late Giren Roy, C/O Jagodish Roy of Jaleshwari Bazar PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

Siliguri Police Commissionerate

- (1) 15 (Fifteen) bottles of "HIMALAYAN GOLD INDIA MADE LIQUOR" each bottle containing 600 ML, MRP Rs.155/- (Total- 9 Liter & Amount Rs 2325/-).
- (2) 03(Three) bottles of "OFFICER CHOICE GRAND WHISKY" each bottle containing 180 ML, MRP Rs.150/- (Total- 540 ML & Amount Rs 540/-).

I SI Pradip Kr Singha of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely (1) Biswajit Roy(22), S/O- Late Giren Roy,C/O Jagodish Roy of Jaleshwari Bazar PS Bhaktinagar Dist. Jalpaiguri to the effect that, today i.e 20.01.2023 evening as per order of O/C Ashighar OP I along with ASI Inzamamul Houqe, C/ 970 Bikash Roy & LCV/570 Lalita Oraon , all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 438 Dt 20.01.2023 in course of which I received information from my source that one Biswajit Roy stored a huge numbers of bottles of liquor inside his shop at Jaleshwari Bazar and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Jaleshwari Bazar area to verify the veracity of information. On reaching at Jaleshwari Bazar ,area as indicated by my source I held raid at the shop of Biswajit Roy at Jaleshwari Bazar .But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the shop of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his shop . I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 20.05 hrs and 20.30 hrs on 20.01.2023

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely (1) Biswajit Roy(22), S/O- Late Giren Roy,C/O Jagodish Roy of Jaleshwari Bazar PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
