I, Smt Rekha Niroula, wife of Sri Hom Sharma, resident of Tari Jote, P.O. New Rangia, P.S. Matigara, Dist- Darjeeling, would like to lodge this complaint against (1) Dilwara Khatun, wife of late Md. Darajuddin, (2) Rikas Rassak, son of Abdul Rassak, (3) Rubina Ahamed, Wife of Rikas Rassak all are resident of Harekrishna Pally, Bagdogra, P.O & P.S Bagdogra, District- Darjeeling on the following effects:-

- 1 That I have purchased land measuring 5 Katha, recorded in L.R. Plot No. 05, L.R. Khatian No. 17, within Mouza Panaullar Chhat, under Hetmuri Gram Panchayat, by Sale Deed being Sale Deed No. 2080/2018 from Dilwara Khatun on 03.04.2018.
- 2 That my husband is a defense personnel and we reside outside wherever my husband is posted.
- 3 That when in the month of June, 2022 I went to my said land for the purpose of demarcation and construction of boundary wall there I came to know from the locality that Dilwara Khatun had no title over the land and there no land is remaining in the record, she sold out all land.
