Azad of Dangipara, near Ashique Manjil, Ward No 06, PS- Siliguri, Dist-Darjeeling (3) Md Ashif (23) S/O Md. Firoz of Cool Depo, near Madrasa, Ward No 07, PS- Siliguri, Dist-Darjeeling (4) Md. Noor (26) S/O Md. Balli of Cool Depo, near Madrasa, Ward No 07, PS- Siliguri, Dist-Darjeeling along with seized articles (i) one knife measuring 13" including handle wrapped from the possession of Md. I, SI Ashim Kr. Das of Khalpara TOP Under Siliguri PS/ SPC do here by lodge this written complaint to the effect that on 24.01.23 at 00.25 hrs I received secret source information that 7-8 persons had assembled at Jhankar More Sabji Bazar, in front of Modern Boys Club ground, Ward No 04 to commit dacoity at the locality. Immediately informed the tip of information to O/C Khalpara TOP and as per his kind direction I, noted the fact in GD book vide Khalpara TOP GDE No 582 dated 24.01.2023 and as per his kind instruction myself along with ASI Uttam Kr. Dhar, ASI Raju Sarkar, C/239 Badal Kr. Barman, C/1048 Gopal Roy, C/174 Pradip Kr Das, C/516 Sunil Roy, CV-916 Amresh Sah left for Jhankar More Sabji Bazar, in front of Modern Boys Club to verify the veracity of the information. At about 00.45 hrs I along with police party arrived at the spot Jhankar More Sabji Bazar, in front of Modern Boys Club and after keeping our vehicle at a distant place we proceeded towards Jhankar More Sabji Bazar, in front of Modern Boys Club on foot and being indicated by the source found from the considerable distance that a gang of seven/eight persons were assembled at Jhankar More Sabji Bazar, in front of Modern Boys Club and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase manage to apprehended 04 (four) persons and others persons fled away from the spot. On interrogation; the apprehended persons disclosed their name, address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that they along with others assembled there in preparation to commit docaity. Accordingly on being search I recovered one knife measuring 13" including handle wrapped from the possession of Md. Taukir (20) S/O Md Jafir which was kept concealed on the back side waist 2) One iron sword measuring 31" Including iron handle recovered from the possession of Parvesh Ali @ Bittu (22) S/O Lt. Md. Azad which he was holding on his hand 3) One iron rod measuring approx 25" pointed one end recovered from the possession of Md Ashif (23) S/O Md. Firoz which he was holding on his hand 4) One iron rod measuring approx 28" pointed one end recovered from the possession of Md. Noor (26) S/O Md. Balli which he was holding on his hand Accordingly, I selzed the above noted recovered articles as per seizure list in presence of witnesses and duly singed by them in between 01:15 hrs to 01:45 hrs and I arrested them U/S 41 Cr.P.C. after explaining the charges against them.
