I, SI Dilip Kumar Pual of Khalpara TOP, under Siliguri Police station do hereby submit this written complaint against above noted accused persons to the effect that on 25.01.23 at 20.40 hrs I received a secret source information that the above noted persons are carrying huge quantity of banned drugs for selling to the local people of Adarsha Nagar area illegally. Accordingly I diarized the matter vide Khalpara TOP GDE No. 625 dated 25.01.23 and inform O.C Khalpara TOP and convey the matter to I/C Siliguri PS and as per their kind direction, I along with ASI Uttam Dhar ASI Raju Sarkar, C/706 Tapan Debnath, C/678 Dipak Mandal, C/ 390 Sujit Paul, C/717 Hirak Roy, left for Adarsha Nagar Near Govt. Saw Mill, Siliguri to verify the veracity of information. On arrival at Adarsha Nagar near Govt. Saw Mill, Siliguri being pointed out by the source, found that three persons were carrying with bag in their hand. Accordingly we intercepted the said persons in presence of two disinterest witnesses namely Rajib Adhikary S/O Jagadish Adhikary of Adarsha Nagar, Ward No 04, near Soni Mndir, PS- Siliguri Dist-Darjeeling (2) Md. Islam S/O Lt. Md. Daud of Santoshi nagar near Ram Janki Mandir Ward No 05

ps- Siliguri, Dist- Darjeeling and on searching found that the said persons were carrying huge quantity of banned Cough Syrup illegally in their bag. On being asked they disclosed their identity as noted above and on demand they failed to produce any valid documents/drug license for carrying and selling huge quantity of Cough Syrup illegally to younger generation of Siliguri area and adjacent area to earn money for his lively hood. Accordingly I informed the matter to O/C Khalpara TOP and I/C P.S as well as I informed the matter to Sri Manobendra Rakshit ACP EB SPC in written and requested him to come at the said place for presence at the time of search and seizure.
