**SUB:- Complaint/F.I.R regarding attack and physical assault causing greivous hurt.**

Dear Sir,

With high regards I, Prabha Tewari Yolmo, D/O Mr. Lakpa Yolmo, resident of Pradhan Nagar, Nepali Busty, Near Tirupati Shiv Mandir, P.O & P.S: Pradhan Nagar, Dist: Darjeeling, humbly submit the following for your kind, prompt and appropriate legal actions please:

1. That I am a permanent resident of Pradhan Nagar, Nepali Busty, Near Tirupati Shiv Mandir, P.O & P.S: Pradhan Nagar, Dist: Darjeeling and my mother and sister have been residing there permanently at our own residence.
2. That on 27<sup>th</sup> January 2023 at around 6.30 pm we got a call from one lady namely Mina Dhungel W/O Suren Dhungel resident of the same locality that our mother has fallen down on the passage way to our house at Pradhan Nagar and that she has been terribly injured and bleeding. Hearing this me and my younger sister hurriedly rushed towards our house to rescue our mother. On reaching there we found out that she had a deep cut on the left side upper eye portion and that she was bleeding badly. At that moment my mother told us that when she was returning from a medicine store nearby and while entering into the passage way towards our house, somebody pushed her and she fell down so badly that her spectacles broke and she got hit on one bomber i.e., a cemented block that was kept in between the middle of the passage. After pressing the wound with some cotton in order to stop the bleeding then I hurriedly ran to the spot and astonishingly found out that the bomber had been removed from that place and there was this line of plants standing on an aluminum table occupying almost half portion of the walking space of the passage area towards our house. When I tried to talk to the people there one lady namely Bunu Dhungel and another lady Mina Dhungel W/O Suren Dhungel became outrageous and started abusing me and attacking me. But still I was trying to control the situation but then again suddenly one boy namely Yogesh Trikhatri S/O Sachin Trikhatri who is a tenant in our house premises as well as their relatives of the above women came over to me and started charging and abusing me and attacking me along with his cousin sister Anushri Dhungel, D/O Bimla Dhungel. In the meantime my father came over there and tried to stop them but they violently attacked us and entered into our house premises with at least eight to ten people i.e., their whole relatives. My mother who was injured was bleeding terribly was inside the house. So with the help of my father me and my sister barged out of the crowd to take our mother to the nearby hospital at Nivedita Nursing Home for immediate medical treatment. Since the wound was very deep and terrible the doctor there advised us to take our mom to another nursing home to be shown to a surgeon and get the stitches done. So all this time we were quite busy with our mother's treatment and could not come to the police station and report the matter immediately.
3. That these four people namely Yogesh Trikhatri S/O Sachin Trikhatri, Anushri Dhungel D/O Bimla Dhungel, Mina Dhungel W/O Suren Dhungel and Bunu Dhungel all are involved in this incident and since their whole relatives stay in the same

locality they are quite violent and have even challenged me and my family as to no law can dare to touch them taking undue advantage of our gentleness and said that no one can dare to do anything to them and dared to show their dadagiri to us. I myself am a lawyer of Siliguri Court and cannot take the law in my hands.

In view of the above I therefore humbly request your good self to kindly lodge this complain/ FIR in your police station and look into the matter and take appropriate legal actions against the above named culprits as they have no fear of the law and they can again attack and do anything to my family and in order to protect my family from these hooligans and oblige us.
