Dear Sir,

With due respect I the undersigned would like to inform you that, at the end of the year of the 2018 (as I could recollect from my memory) at that relevant time I was an employee of SIS Securities at Ashram Para, P.O & P.S Siliguri, Dist. Darjeeling. At that time I met with one Jahangir Alam (Contact No. 9614897858) in the said office and he introduced himself as a constable attached with Chachal Police Station at Maldah. On one occasion said Mr. Alam told me that he has a good source in the department of the police for arranging job and on the very inception I did not believe him but during the frequent meeting whenever he used to come in the said office for his other work, he somehow took me in his confidence and he assured me that he can arrange a job for me as Assistant Sub-Inspector in the department of West Bengal police. Being an educated lady I thought it will he wise for me to join as a police personnel in the police department.

Said Mr. Alam has told me that for securing the said job I have to pay a sum of Rs. 5,00,000/- (Rupees Five Lac) only to him but I was not in a position to pay the said entire amount at a time but it was settled that the said amount will be paid in two installments and I paid him a sum of Rs. 4,00,000/- (Rupees Four Lac) only in cash in the month of January, 2019 in my rented house at Pradhan Nagar, Siliguri in presence of his one friend Sri Jatin Karmakar (Contact No. 9593692285, 8327508407, 3145870663) and he is also a police personnel attached with Islampur Police Station as he introduced himself to me and at that time they assured me that within 6 months from that day I have to appear for written examination and thereafter I have to appear also for interview and physical examination and this entire process will be completed within more or less one year and after that I will get the written appointment letter from the department of police and it was also decided that at the time of getting the appointment letter I have to pay the balance amount i.e. Rs. 1,00,000/- (Rupees One Lac) only to

Siliguri Police Commissionerated like to further inform you that, inspite of receiving the said amount, Mr. Alam did not give me a satisfactory answer regarding my appearance in the examination after clapsing of a considerable period and I could realize that said Mr. Alam made me fool and took the said money which I have collected from my parents and friends and I requested him to return back

my money but he started to neglect me including my phone calls but due to the continuous pressure Mr. Alam returned me a sum of Rs. 40,000/-(Rupees Forty Thousand) only in the bank account of my mother on 12.05.2020 and thereafter he also returned a sum of Rs.50,000/- (Rupees Fifty Thousand) only in the account of my mother on 17.08.2020 and he convinced me that he will return the said balance amount of a sum of Rs. 3,10,000/- (Rupees Three Lac Ten Thousand) only very shortly and I trusted upon him on good faith and I waited for a considerable time but till this day he did not return the said amount with so many flimsy ground including the reason for lockdown and whenever I asked for the said rest amount.

I would like to further inform you that on 22.01.2023 I found Mr. Alam with said Jatin Karmakar at Pradhan Nagar, Siliguri and getting them, I again requested to return back my said amount but they refused to return the same and moreover he abused the filthy languages towards me which cannot be uttered in a civilized country and moreover they told me that they are the police personnel and I can't do anything against them and due to their misbehavior I was very shocked and became seriously ill and for that I could not lodge the complaint soon after the said incident and at present I have no other alternative but to lodge this complaint.

Under the above circumstances I would like to request you to investigate the matter and recover the said amount and do needful against said Jahangir Alam and his associate Jatin Karmakar for the ends of justice.
