Sir,

In producing herewith one accused person named Pradyum Thapa(27) S/O- Dinesh Thapa Of Dhajeahope Gaw P.O- Nagari ,Ps.Sukiapukari ,Dist- Darjeeling under arrest along with following articles under proper seizure.

12(twelve) bottles of Tuborg Strong Premium Beer each bottle containing 650 ml, manufactured by Carlsberg india Pvt. Ltd. Vill. Bellmuri Mouza-Bagnan,P.O. Chaitanyabati,P.S.-Dhaniakhali, Dist Hooghli-712301 West Bengal, India, Out of which one bottle has been taken as sample for examination.

I, ASI Ashit Singha of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Pradyum Thapa(27) S/O- Dinesh Thapa Of Dhajeahope Gaw, P.O- Nagari ,Ps.Sukiapukari ,Dist- Darjeeling to the effect that today on 29.01.2023 at 17.30 hrs received a source information that one person is selling liquor in his restaurant of NIMTO situated at Gurung bosty ,near Veerjawan more, under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to you and as per your kind direction I along with Constable 762 Mojibul Rahman, CV/128 Ajoy Kumar Sahani , CV 645 Pankaj Gupta All of Pradhannagar Ps had been to Gurung bosty ,near Veerjawan , under Pradhan Nagar Police Station to verify the veracity of the information . This refers to Pradhannagar P.S. GDE no.866, Dt. 29.01.23. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his Nimto restaurant of Gurungbosty, I along with my force cordoned the restaurant and was able to detain the above noted person. Thereafter on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Pradyum Thapa(27) S/O- Dinesh Thapa Of Dhajeahope Gaw P.O- Nagari ,Ps.Sukiapukari ,Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 18:05 hrs to 18.35 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Pradyum Thapa(27) S/O- Dinesh Thapa Of Dhajeahope Gaw P.O- Nagari ,Ps.Sukiapukari ,Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
